AN ORDINANCE CREATING CERTAIN POSITIONS IN THE PLANTILLA OF THE LOCAL YOUTH DEVELOPMENT OFFICE, THE CITY HEALTH OFFICE, THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE, AND THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE AND ABOLISHING ONE POSITION IN THE PLANTILLA OF THE CITY HEALTH OFFICE OF THE CITY OF BACOR, CAVITE FOR FISCAL YEAR 2022.

WHEREAS, Section 11, (viii) of Republic Act No. 10160 (the "Charter City of Bacoor, Cavite") empowered the Sangguniang Panlungsod to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government.

WHEREAS, the Office the City Mayor sent a letter requesting the Sangguniang Panlungsod to approve an ordinance creating various positions under the plantilla of the City Social Welfare Development Office (CSWDO), the City Health Office (CHO), the City Environment and Natural Resources Office (CENRO), and the Local Youth Development Office for fiscal year 2022.

WHEREAS, the creation of the said positions will greatly aid the said offices in the efficient delivery of basic services to the public.


