**AN ORDINANCE TRANSFERRING THE PLANTILLA OF MARKET SUPERVISOR IV AND MARKET INSPECTOR II FROM THE "OPERATIONS OF PUBLIC MARKET UNIT" TO THE OFFICE OF THE MAYOR OF THE CITY OF BACOR, CAVITE.**

**WHEREAS**, Section 11. (viii) Republic Act No. 10160 (the "Charter City of Bacoor, Cavite") empowered the Sangguniang Panlungsod to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government.

**WHEREAS**, the Office the City Mayor sent a letter requesting the Sangguniang Panlungsod to transfer the plantilla of Market Supervisor IV and Market Inspector II from the "Operations of Public Market Unit" to the Office of the City Mayor.

**WHEREAS**, the said request was in reaction to the recommendation of the Provincial Budget Office after it noticed that the said unit only has two remaining plantilla positions.

**BE IT ORDAINED** by the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, Cavite in Regular Session assembled THAT:

**Section 1. Transfer of Plantilla Positions and Funding.**

The following positions in the plantilla of the Operations of Public Market Unit are hereby transferred to the Office of the City Mayor:

**Section 2. Abolition of Operations of Public Market Unit.**

As a consequence of the foregoing transfer of the two remaining plantilla positions of the Operations of Public Market Unit, the said unit is hereby abolished.

**Section 3. Date of Effectivity.** – This Ordinance shall take effect immediately after it has been published once in a newspaper of general circulation in the City of Bacoor, Cavite.

**Section 4. Separability.** – Any provision of this Ordinance not declared void by any court of law shall remain valid.

**Section 5. Dissemination.** The Sangguniang Panlungsod Secretariat is hereby directed to furnish the Civil Service Commission, the Human Resources Development and Management Department, the Office of the City Budget Officer, the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and all government offices concerned with copies of this Ordinance.
