AN ORDINANCE REALIGNING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FROM TELEPHONE EXPENSES UNDER MAINTENANCE AND OTHER OPERATING EXPENSES TO INSURANCE EXPENSES UNDER MAINTENANCE AND OTHER OPERATING EXPENSES OF THE 2022 ANNUAL BUDGET OF THE CITY GENERAL SERVICES OFFICE (GSO) FOR THE PAYMENT OF INSURANCE COVERAGE PREMIUMS OF ALL BACoor CITY GOVERNMENT MOTOR VEHICLES.

WHEREAS, submitted for review and approval of the Sangguniang Panlungsod was the proposed realignment of Five Hundred Thousand Pesos (P500,000.00) from the 2022 Annual General Fund of the City General Services Office to augment the funds set aside to pay the insurance coverage premiums of all Bacoor City Government motor vehicles.

WHEREAS, the Sanggunian was informed by the City Budget Officer that the said amount to be realigned shall no longer be used by the City General Services Office for "Telephone Expenses" under "Maintenance and Other Operating Expenses" budget of the said department.

WHEREAS, there is a need to realign the amount of Five Hundred Thousand Pesos (P500,000.00) originally intended for "Telephone Expenses" from the "Maintenance and Other Operating Expenses" budget of the City General Services Office to be able to provide funds for the renewal of the insurance coverage of all the motor vehicles being used by the city government.

WHEREAS, the aforementioned appropriation will be sourced from the Telephone Expenses of Maintenance and Other Operating Expenses of the 2022 Annual General Fund of the City General Services Office, to wit:

NOW THEREFORE, upon motion of Hon. Rogelio M. Nolasco, unanimously seconded by the councilors present in 18th Regular Session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds from the 2022 Annual Budget under 'Telephone Expenses' of the 'Maintenance and Other Operating Expenses' of the General Services Office for the payment of insurance coverage premiums of all Bacoor City Government motor vehicles.

Be it enacted by the Sangguniang Panlungsod of Bacoor City, Cavite in its Regular Session assembled that:

Section 1. The purpose of this Ordinance is to appropriate the amount of Five Hundred Thousand Pesos (P500,000.00) for the payment of the insurance coverage premiums of all city government motor vehicles.

Section 2. The above-mentioned amount of Five Hundred Thousand Pesos (P500,000.00) shall be realigned from the 'Telephone Expenses' under the 'Maintenance and Other Operating Expenses' of the City General Services Office.

Section 3. The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

Section 4. This Appropriation Ordinance shall take effect upon its approval.
