AN ORDINANCE AMENDING SECTION 1 OF CITY ORDINANCE NO. 230-2022, SERIES OF 2022 ENTITLED: "AN ORDINANCE CREATING CERTAIN POSITIONS IN THE PLANTILLA OF THE LOCAL YOUTH DEVELOPMENT OFFICE, THE CITY HEALTH OFFICE, THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE, AND THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE AND ABOLISHING ONE POSITION IN THE PLANTILLA OF THE CITY HEALTH OFFICE OF THE CITY OF BACOR , CAVITE FOR FISCAL YEAR 2022".

BE IT ORDAINED by the 5th Sangguniang Panlungsod of Bacoor, Cavite in regular session assembled that:

Section 1. Section 1 of City Ordinance No. 230-2022 is hereby amended and shall henceforth read as follows:

"Section 1. Creation of Positions and Funding . The following positions in the plantilla of the following offices – the salaries of which shall be appropriated in the Annual Budget for Calendar Year 2023 of the city government – are hereby created.

The person to be appointed as City Government Assistant Department Head 1 in the Bacoor City Health Office must possess the following qualifications, to wit:

- 1.1 Relevant's Bachelor's Degree (Doctor of Medicine - M.D.);
- 1.2 Passed the Medical Board Examinations pursuant to Republic Act No. 1080;
- 1.3 Relevant Training and/or experience in helath promotion, epidemiology surveilance, disaster risk reduction and management for health, and
- 1.4 Three (3) years of relevant work experience".
