**AN ORDINANCE REGULATING THE USE OF THE FIRE PREVENTION AND TRAINING FACILITY SITUATED AT BARANGAY MOLINO IV, BACOR CITY, CAVITE, NAMING THE SAID EDIFICE AS THE "STRIKE FIRE AND RESCUE VILLAGE", AUTHORIZING THE COLLECTION OF FEES FOR ITS USE BY THE PUBLIC, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.**

**WHEREAS**, Section 129 of Republic Act No. 7160 (the "Local Government Code of 1991") provides that each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provisions herein, consistent with the basic policy of local autonomy.

**WHEREAS**, under Section 16 of RA 7160, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

**WHEREAS**, under Section 13, (1) (b) of RA 7160 the sanggunians of highly urbanized cities and of component cities whose charters prohibit their voters from voting for provincial elective officials, hereinafter referred to in this Code as independent component cities, may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction:

(1) City barangays, upon the recommendation of the sangguniang barangay concerned;

(2) City roads, avenues, boulevards, thoroughfares, and bridges;

(3) Public elementary, secondary and vocational or technical schools, community colleges and non-chartered colleges;

(4) City hospitals, health centers and other health facilities; and

(5) **Any other public place or building owned by the city government.** (Emphasis supplied.)

**WHEREAS**, the local government of the City of Bacoor constructed and owns a public building on a 795-square meter parcel of land with a floor area of 236.65 square meters situated at Barangay Molino IV, Bacoor City, Cavite intended to be used as a facility where school children, their teachers, and parents may be taught the rudiments of fire prevention and safety as well as the basic tenets of fire fighting.

**WHEREAS**, an ordinance must be passed regulating the use of the said facility, authorizing the collection of fees for the use of the same by the public, naming the said public building, and imposing fines for violations hereof.

**NOW THEREFORE**, be it Ordained by the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, Cavite in Regular Session duly assembled that:

**Section 1. Title.**

This Ordinance shall be known as the "**2023 Strike Fire and Rescue Village Ordinance of the City of Bacoor**".

**Section 2. Purposes.**

This Ordinance provides for the rules and regulations governing the use of the public building situated at Barangay Molino IV, Bacoor City, Cavite on a 795-square meter parcel of land with a floor area of 236.65 square meters intended to be used as a facility where school children, their teachers, and parents may be taught the rudiments of fire

**Section 3. Name of the Public Building.**

The public building situated at Barangay Molino IV, Bacoor City, Cavite on a 795-square meter parcel of land with a floor area of 236.65 square meters intended to be used as a facility where school children, their teachers, and parents may be taught the rudiments of fire prevention and safety as well as the basic tenets of fire fighting shall hereinafter be known as the **"Strike Fire and Rescue Village of Bacoor"**.

**Section 4. Fees.**

The following fees shall be collected from the persons who shall use the said facility:

For Public School Children/Teachers/ Parents	For Private School Children/Teachers/ Parents	For College Students, Employees
P20.00 Entrance Fee	P30.00 Entrance Fee	P40.00 Entrance Fee
P50.00 Training Fee (if Bacoor City Resident) P100.00 (if not a resident of Bacoor City)	P60.00 Training Fee (if Bacoor City Resident) P150.00 (if not a resident of Bacoor City)	P70.00 Training Fee (if Bacoor City Resident) P200.00 (if not a resident of Bacoor City)

An order of payment shall be issued by the BFP to the persons above-mentioned before the fees above can be paid at the Office of the City Treasurer. In case the user is a minor, the said order of payment shall be issued to their teacher/s, parent/s or guardian/s. In case the users shall comprise of school children as part of an official school activity, the order of payment shall be issued to the principal of the said school.

The Office of the City Treasurer shall issue an official receipt under the name written on the said order of payment.

### Section 5. Use of Facility as Events Place/Payment of Rental Fees.

In view of the unique design and aesthetics of the facility, the BFP is hereby authorized to allow the use thereof as an events venue for birthday parties and photography sessions. A rental fee of P1,000.00 for the first three hours of such event shall be paid to the Office of the City Treasurer if the birthday celebrant or one of the models during the photo sessions is a resident of Bacoor City. An additional fee of P500.00 shall be charged for use of the facility in excess of 3 hours.

A rental fee of P2,000.00 for the first three hours of such event shall be paid to the Office of the City Treasurer if the birthday celebrant or one of the models during the photo sessions is NOT a resident of Bacoor City. An additional fee of P700.00 shall be charged for use of the facility in excess of 3 hours.

A fee of P1,000.00 shall be paid by the organizer of the event for each equipment that might be damaged during the event.

No party or photo shoot shall be allowed to be held at the facility whenever there is a scheduled educational tour/field trip.

### Section 6. Creation of Trust Fund/Use of Collected Fees.

The fees collected from the public for the use of the facility shall be deposited in a special trust fund to be deposited with a government financial institution and shall be used solely for the maintenance, repair, and upgrading of the **Strike Fire and Rescue Village**.

### Section 7. BFP to Supervise Use of Facility.

The BFP, headed by the duly designated Fire Marshal to the City of Bacoor, shall have over-all supervision and control of the facility during the existence of the Usufruct Agreement mentioned above. The manner by which the facility shall be used, the number of people who shall use it at any given time, and the way the people who shall use the same shall be trained and instructed on fire

prevention and safety shall be the prerogative of the Fire Marshal subject to the approval of the City Mayor.

### Section 8. Training Program.

The BFP, subject to the approval of the City Mayor, shall formulate the training program to be used at the facility. The said training program must take into account the safety of the users, the ability of those users to absorb and understand the information/training to be imparted to them, the age/gender of the said users, as well as other factors that may affect the effectiveness of the said program.

### Section 9. Installation of Scanners and CCTV Cameras.

The City Engineering Office and E-Governance Department are hereby authorized to install closed circuit television (CCTV) cameras at strategic locations within the facility. The said CCTV cameras shall be maintained, operated, and monitored by the BDRRMO and the E-Governance Department.

### Section 10. Access Hours.

The facility shall only be used from 7:00 A.M. to 5:00 P.M. every day including public holidays.

The City Mayor is empowered to modify the access hours under this Ordinance upon the recommendation of the BFP.

### Section 11. Penalties.

- The violator of any of the provision of this City Ordinance shall be punishable with an administrative fine of THREE THOUSAND PESOS (PHP 3,000.00) payable to the Office of the City Treasurer.
- The following acts shall be punishable with an administrative fine of FIVE THOUSAND PESOS (PHP 5,000.00) payable to the Office of the City Treasurer or with a thirty (30) day imprisonment or with both fine and imprisonment upon conviction by the court of proper jurisdiction, to wit:

- Commission of any act of graft and corruption while at the facility or in relation

to the use, operation, maintenance, or upgrading thereof;

2. Use of abusive, discourteous, violent, or reckless behaviour by a trainor working at the facility;
3. Disregard of the approved training program by an instructor;
4. Deliberate infliction of any damage to any part of the facility or to any equipment thereat; and
5. Commission of any act analogous to the acts above mentioned.

### Section 12. Implementing Rules and Regulations.

The BFP and the Department of Education with the assistance of the Office of the City Legal Service shall formulate the implementing rules and regulations of this Ordinance and submit the same to the City Mayor within thirty (30) calendar days after its date of effectivity. The said implementing rules and regulations must be approved by the City Mayor and shall be published at least once in a newspaper of general circulation within the Province of Cavite and submitted to the UP-ONAR before its effectivity.

### Section 13. Repeal.

All ordinances, resolutions, implementing rules and regulations, and executive orders related to this Ordinance are considered expressly repealed or modified.

### Section 14. Separability.

In case any provision of this Ordinance is declared void by a court of law, the remaining provisions of this measure not affected by the said judicial declaration shall remain valid and enforceable.

### Section 15. Effectivity.

This Ordinance shall become effective upon its approval and after it has been published for a minimum of three (3) consecutive weeks in a newspaper of general circulation in the Province of Cavite. A copy of this Ordinance shall be submitted to the UP-ONAR before its effectivity.
