CITY ORDINANCE NO. 286-2023

AN ORDINANCE AMENDING SECTION 12 OF CITY ORDINANCE NO. 157-2021 (THE "LOCAL ECONOMIC AND INVESTMENTS PROMOTION ORDINANCE OF THE CITY OF BACOOR") WHICH CREATED THE LOCAL ECONOMIC AND INVESTMENTS PROMOTION OFFICE (LEIPO) OF THE CITY OF BACOOR, CAVITE.

WHEREAS, City Ordinance No. 157-2021 (the "Local Economic and Investments Promotion Ordinance of the City of Bacoor") was approved by the Sangguniang Panlungsod on 31 May 2021.

WHEREAS, the said ordinance was approved in compliance with Memorandum Circular No. 2010-113 of the Department of Interior and Local Government which encouraged local government units to designate a Local Economic and Investments Promotions Officer who would focus on the promotion and facilitation of their local economic development.

WHEREAS, the said office and the position of City Government Department Head 1 was created by virtue of Sections 9, 10, and 11 of the said ordinance. Section 12 of the said ordinance provides that "to minimize the expenses of the city government in the implementation of this Ordinance, the City Mayor is hereby empowered to assign existing personnel culled from the various departments of the city government who are familiar and skilled in the processing of various permits, clearances, and certificates being issued by the city government in relation to the various land development, business, and commercial activities subject of this Ordinance. "

WHEREAS, to date, no employee of the city government has been assigned to the said office thereby hampering the capability of the local government to comply with the

provisions of DILG Memorandum Circular No. 2010-113 and with the various objectives of City Ordinance No. 157-2021.

WHEREAS, it is necessary that the Local Economic and Investments Promotion Office be constituted as a full-pledged department of the city government to further enhance the growth of the local economy of the City of Bacoor.

NOW, THEREFORE, during regular session assembled, upon motion of Councilor Reynaldo D. Palabrica unanimously seconded by the rest of the council, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the 5th Sangguniang Panlungsod of the City of Bacoor THAT:

Section 1. Amendment of Section 12 of City Ordinance No. 157-2021. Section 12 of City Ordinance No. 157-2021 is hereby amended and shall henceforth read as follows:

"Section 12. Creation of New Positions. The following positions are hereby created to comprise the Local Economic and Investments Promotion Office (LEIPO) under the Office of the City Mayor:

- a. Division Head — Supervising Administrative Officer SG 22. He/she must have the following qualifications in order to be appointed to the said position:
 - i. Relevant Bachelor's Degree
 - ii. at least 5 years work experience in government service;
 - iii. With 16 hours of relevant training.
- b. Administrative Section:
 - i. Administrative Assistant III (Computer Operator III) SG 9;
 - ii. Administrative Aide IV (Clerk II), SG 4;
 - iii. Administrative Aide II, SG 2.
- c. Economic Development Management Section:
 - i. Development Management Officer III, SG 18;
 - ii. Development Management Officer II, SG 15;
 - iii. Economic Researcher, SG 9;
 - iv. Clerk 1, SG 3. He/she must have the following qualifications in order to be appointed to the said position:
 - a. Career Service Sub-Professional Eligibility
 - b. Completion of at least two (2) years studies in college
 - v. Driver, SG 4. He/she should have a valid Professional Driver's License in order to be appointed to the said position.

The above-mentioned personnel to be appointed to the said positions must comply with the various regulations of the Civil Service Commission and shall be placed under

the direct control and supervision of the City Government Department Head I." (Underscoring supplied)

Section 2. Effectivity. This Ordinance shall become effective immediately upon its posting on the official website of the City of Bacoor, Cavite and on at least three conspicuous places within the City.

Section 3. Repeal. Any provision of City Ordinance No. 157-2021 or of any other city ordinance that is inconsistent with the provisions of this Ordinance are hereby repealed.

Section 4. Separability. The nullification of any provision hereof or of City Ordinance No. 157-2021 by a court of law shall not render void the remaining provisions of this Ordinance not affected by the said judicial declaration.
