CITY ORDINANCE NO. 316-2023 Series of 2023

AN ORDINANCE CREATING THE POSITIONS OF TWO (2) ENVIRONMENTAL MANAGEMENT SPECIALIST 1 AND ONE (1) ADMINISTRATIVE OFFICER I IN THE PLANTILLA OF THE CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO) OF THE CITY GOVERNMENT OF BACOR , PROVINCE OF CAVITE.

WHEREAS, on 29 September 2023, the Office of the Sangguniang Panlungsod received an endorsement letter from the Office of the City Mayor requesting the creation of two (2) Environmental Management Specialist 1 and one (1) Administrative Officer I positions in the plantilla of the City Environment and Natural Resources Office (CENRO) of the City Government of Bacoor , Province of Cavite.

WHEREAS, the above-mentioned matter was referred to the Committee on Ethics, Appointments and Government Re-Organization for further study and evaluation.

WHEREAS, the Committee on Ethics, Appointments and Government Re-Organization conducted a committee hearing on the said request and it eventually recommended for its approval.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod in Regular Session assembled THAT:

Section 1. Creation of Positions. The following permanent positions under the City Environment and Natural Resources Office (CENRO) which salaries shall be appropriated in the Annual Budget for Calendar Year 2024 of the city government are hereby created, to wit:

Section 2. Effectivity. -- This Ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) other conspicuous places in the City of Bacoor not later than five (5) days after the approval thereof.

Section 3. Separability. -- Any provision of this Ordinance declared void by any court of law shall not affect the other provisions hereof not affected by such declaration.

Section 4. Dissemination. --The Sangguniang Panlungsod Secretariat is hereby directed to furnish the Civil Service Commission, the Human Resources Development and Management Department, the Office of the City Budget Officer, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and all government offices concerned with copies of this ordinance immediately after its date of effectivity.
