WHEREAS, Section 13 of Republic Act No. 7160 (the "Local Government Code of 1991") empowered the Sangguniang Panlungsod to name public health centers upon the recommendation of the Local Health Board.

WHEREAS, on 15 February 2024, the Local Health Board of the City of Bacoor issued Resolution No. 04-S-2024 and recommended that the above-mentioned health center be named as the "**24/7 CITY OF BACOR LYING-IN AND EYE CENTER**".
