CITY ORDINANCE NO. 355-2024 Series of 2024

AN ORDINANCE REQUIRING THE MANDATORY REGISTRATION AND ACCREDITATION OF BARANGAY HEALTH WORKERS IN THE CITY OF BACOR, CAVITE PURSUANT TO R.A. NO. 7883 AND IMPOSING PENALTIES FOR VIOLATIONS HEREOF.

WHEREAS, Republic Act No. 1123 (the "Universal Health Care Act") states that local government units shall ensure an adequate and equitable number of human resources for health at all levels, including Barangay Health Workers (BHWs) to assist in the delivery of comprehensive and quality health care services.

WHEREAS, the COVID-19 pandemic and the various health calamities that visited the City of Bacoor, Cavite and the rest of the country showed conclusively that Barangay Health Workers are essential components of the nation's health workforce as members of the Barangay Health Emergency Response Team (BHERT).

WHEREAS, Republic Act No. 7883 (the "BHWs' Benefits and Incentives Act of 1995") and its Implementing Rules and Regulations were issued to protect the interest of the BHWs and provide them with support for their continual service.

WHEREAS, the Department of Health and the Department of Interior and Local Government issued Joint Memorandum Circular 2023 – 001 to reinforce RA 7883 to ensure BHW's uninterrupted delivery of primary care services to their communities.

NOW THEREFORE, be it ordained by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite THAT:

Section 1. Title. This Ordinance shall be known as the **"Mandatory Barangay Health Worker Registration and Accreditation Ordinance of the City of Bacoor"**.

Section 2. Mandatory Registration and Accreditation of Barangay Health Workers. Upon the effectivity of this Ordinance and its Implementing Rules and Regulations, the registration and accreditation of all barangay health workers in compliance with the provisions of Republic Act No. 7883 and its implementing rules and regulations shall become mandatory.

SECTION 3. Prohibited Acts. The following acts and omissions are hereby prohibited:

3.1. Failure of to register and accredit barangay health workers working within the City of Bacoor, Cavite within the period and in compliance with the manner prescribed in the implementing rules and regulations of this Ordinance;

3.2. Acts or omissions similar or analogous to the foregoing.

Section 4. Penalties. Any person convicted by a competent court of law for failing to register or accredit barangay health workers in the manner prescribed in the implementing rules and regulations of this Ordinance shall be required to pay a fine amounting to P5,000.00.

Section 5. Implementing Rules and Regulation. The OCLS, in coordination with the CHO, and the Office of the City Administrator, shall submit the proposed implementing rules and regulations of this ordinance for the approval of the City Mayor not more than sixty (60) days after the date of effectivity hereof.

Section 6. Automatic Review. The Sangguniang Panlungsod shall automatically review this Ordinance

Section 7. Repeal. All ordinances, resolutions, orders, and regulations of the City Government inconsistent with the provisions hereof are hereby repealed and/or modified accordingly.

Section 8. Separability. Any provision hereof not affected by a judicial order declaring any part of this Ordinance void or unconstitutional shall remain valid.

Section 9. Effectivity. This Ordinance shall become effective immediately after it has been published in a newspaper of general circulation in the Province of Cavite.
