**AN ORDINANCE AMENDING CITY ORDINANCE NO. 14-2018  
AND REVISING THE ORGANIZATIONAL STRUCTURE AND  
STAFFING PATTERN OF THE PERSONS WITH DISABILITIES AFFAIRS  
OFFICE PURSUANT TO REPUBLIC ACT NO. 10070.**

**WHEREAS**, Section 76 of Republic Act No. 7160 ("RA 7160" or the "Local Government Code of 1991") provides that every local government unit shall design and implement its own organizational structure and staffing pattern considering its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

**WHEREAS**, Section 458, par. (1), (viii) of RA 7160 and Section 11, par. 1 (viii) of Republic Act No. 10160 ("RA 10160" or the "Charter of the City of Bacoor") empowered the Sangguniang Panlungsod to determine the positions and the salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly and mainly from the city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government.

**WHEREAS**, to ensure that persons with disabilities (PWDs) fully enjoy the benefits and privileges provided for under Republic Act No. 9442 ("An Act amending Republic Act No. 7211, entitled, "The Magna Carta for Disabled Persons and for Other Purposes"), the National Council on Disability Affairs (NCDA) issued Administrative Order No. 001, series of 2008, providing mechanisms for the issuance of Persons With Disabilities Identification Cards (PWD-IDC), and NCDA

Administrative Order No. 003 which provides guidelines for the computerization of the issuances of the said ID card.

**WHEREAS**, on 4 September 2023, Joint Circular No. 01-2023 was issued by the Department of Social Welfare and Development (DSWD), the Department of Interior and Local Government (DILG) and by the NCDA which modified the process of issuing PWD IDs by requiring the Persons with Disability Affairs Office (PDAO) of every local government to facilitate the issuance of PWD IDs and for local social welfare development offices to assist the PDAO after such IDs are issued.

**WHEREAS**, the PDAO of the City of Bacoor was created by virtue of City Ordinance No. 14-2018. However, the said office is currently understaffed and is incapable of carrying out the guidelines on the issuance of PWD IDs mandated by Joint Memorandum Circular No. 01-2023 and will require the assistance of other city government departments while its staffing pattern and organizational set-up is being reviewed by the Sangguniang Panlungsod.

**WHEREAS**, on 5 December 2023, the Sangguniang Panlungsod enacted City Ordinance No. 333-2023 (the "PWD ID Regulation Ordinance of the City of Bacoor").

**WHEREAS**, Section 6 of City Ordinance No. 333-2023 provides that:

**"Section 6. Implementation.** The City Social Welfare and Development Office (CSWDO), the Persons with Disability Affairs Office (PDAO), and the City Health Office (CHO) shall jointly implement this Ordinance in the following manner

6.1. The CHO shall take the lead in identifying whether a person who does not have an apparent, physical disability qualifies as a PWD under Department of Health Administrative Order No. 2013-0005-A, DILG Memorandum Circular No. 017, Series of 2022, DILG Memorandum Circular No. 2021-041, and other related government issuances. Any question on whether a person qualifies as a PWD shall be settled with finality by the CHO.

6.2. The PDAO shall take the lead in ensuring that all departments and offices of the City Government are correctly and consistently enforcing this Ordinance and other related laws and city ordinances. The PDAO shall submit to the Sangguniang Panlungsod a report before the end of each year on how this

Ordinance and other related laws and city ordinances pertaining to PWDs were implemented by the City Government.

6.3. The CSWDO shall take the lead in the issuance and renewal of PWD-IDC but only while the PDAO does not have the personnel to perform the task of issuing and renewing the said IDs. Once the PDAO becomes fully capable of performing the duty of issuing and renewing the PWD IDs, the City Mayor shall issue an executive order directing the PDAO to take over the duty of issuing and renewing PWD IDs and the CSWDO to assist PWDs who hold the said identification cards. All records related to the issuance and renewal of the said identification cards and all questions on the validity of a card and the manner by which it should be used shall be settled by the PDAO with finality."

**WHEREAS**, in view of all the foregoing there is a pressing need to amend Sections 3, 4, and 5 of City Ordinance No. 14-2018 by revising the organizational structure and staffing pattern of the PDAO and the manner by which the head of the said office shall be appointed in order to enable the said office to deliver the various services mandated by law for the benefit of PWDs such as, but not limited to, the issuance of PWD IDs.

**NOW, THEREFORE**, this Ordinance is hereby enacted by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite, to wit:

**SECTION 1. Title.** This Ordinance shall be known as the "**Persons with Disabilities Affairs Office Reorganization Ordinance of Bacoor**".

**SECTION 2. Amendment of Sections 3, 4 and 5 of CO 14-2018.** Section 5 of City Ordinance No. 14-2018 is hereby amended and shall henceforth read as follows:

**Section 3. Qualifications of the City Persons with Disabilities Affairs Officer (City Department Head 1).** The PDAO herein established shall be headed by a City Persons with Disabilities Affairs Officer (City Department Head 1) with salary grade 25 who must possess all the minimum qualifications for the said position set forth by the Civil Service Commission.

**Section 4. Manner of Appointment.** The City Persons with Disabilities Affairs Officer shall be appointed by the City

Mayor in the manner prescribed by law and pertinent civil service regulations. In view of the importance of the PDAO in the delivery of various social services to PWDs, the City Mayor is hereby authorized to appoint an officer-in-charge of the said Office until a person qualified to fill the said position is appointed in accordance with relevant civil service regulations.

**Section 5. Organizational Structure, Staffing Pattern, and Funding.** The following items in the plantilla of the PDAO are hereby created:

Items	Position Title	Salary Grade
1	Administrative Assistant II (Clerk IV)	8
1	Administrative Assistant I (Computer Operator I)	7
1	Administrative Aide IV (Clerk II)	4
1	Administrative Aide III (Driver I)	3

The persons to be appointed to the positions mentioned above by the City Mayor must possess all the minimum qualifications set forth by the Civil Service Commission and shall receive the benefits, salaries, and emoluments as mandated by law and pertinent civil service regulations. Once appointed, the said persons shall work under the City Persons with Disabilities Affairs Officer and shall assist him/her in fulfilling the various duties and functions of his/her office as mandated by law or city ordinance or as ordered by the City Mayor.

The funds needed to implement this Ordinance shall be appropriated in the Annual Budget of the City Government for Fiscal Year 2025.

**SECTION 6. Separability Clause.** In case any provision of this Ordinance is declared void by a court of law, the remaining parts of this Ordinance not affected by the said declaration will remain valid.

**SECTION 7. Repeal Clause.** All ordinances, resolutions, and executive orders that are inconsistent or are in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 8. Effectivity.** This Ordinance shall become effective immediately after it has been published at least once in a newspaper of general circulation in the Province of Cavite.

AN ORDINANCE ESTABLISHING THE PERSONS WITH DISABILITIES  
AFFAIRS OFFICE OF THE CITY OF BACOR, CAVITE.

WHEREAS, pursuant to Republic Act No. 10070, otherwise known as "An Act Establishing An institutional Mechanism to Ensure the Implementation of Programs and Services For Persons with Disabilities", the City Government of Bacoor is mandated to create and establish an office that will cater to the needs of Persons with Disabilities;

WHEREAS, the establishment of the said office shall be a bridge and liaison of Persons with Disabilities to the mainstream of society;

WHEREAS, the creation of this office will ensure the promotion of the welfare of persons with disabilities;

NOW, THEREFORE:

Be it ordained by the Sangguniang Panlungsod of the City Bacoor, Cavite in regular session assembled that:

**Section 1. Title.** This Ordinance shall be known as the "Persons with Disabilities Affairs Office (PDAO) Ordinance of Bacoor City".


**Section 2. Functions of the Office.**—The PDAO shall have the following functions:







- b) To coordinate the implementation of the provisions of RA 10070, Batas Pambansa 81g, 344 otherwise known as the Accessibility Law, and other relevant laws at the local level;
- c) To present PWDs in meetings of local development councils and other special bodies;
- d) To recommend and enjoin the participation of Non-Government Organizations (NGOs) and People's Organizations (POs) in the implementation of all disability-related laws and policies;
- e) To gather and compile relevant data on PWDs within their localities;
- f) To disseminate information, which shall include, but not limited to, programs and activities for PWDs, statistics on PWDs, including children with disability, and training and employment opportunities for PWDs;
- g) To submit reports to the office of the local chief executive on the implementation of programs and services for the promotion of the welfare of PWDs in their respective areas of jurisdiction;
- h) To ensure that policies, plans and programs for the promotion of the welfare of PWDs are funded by both the national and local government;
- i) To seek donations in cash or in kind from the local or foreign donors and implement an approved work plan for PWDs in accordance with existing laws and regulations; and
- j) To perform such other functions as may be necessary for the promotion and protection of the welfare of the PWDs.

**Section 3. Qualifications of the PDAO Head.** The PDAO herein established shall be headed by a PWD Affairs Office Head who must possess the following qualifications:

- a) A Filipino citizen and resident of the city at least (1) year prior to his/her appointment;
- b) Able to read and write;
- c) Must be a bonafide member of a PWD Organization duly-accredited by either the Sangguniang

Panlungsod, the city government or by any national government agency with a track record of at least (3) three years;

- d) Must not have been convicted of any crime involving moral turpitude; and
- e) Must be physically and personally able to perform the duties and responsibilities of the office.

**Section 4. Manner of Appointment.** Three (3) nominees for the Head of the PDAO shall be chosen and recommended in a general assembly by and among the organization of PWDs in the city known as "Convenors". The three (3) nominees shall be forwarded to and shall be subjected to the procedures of the Personnel Selection Board (PSB). For the purpose of the appointment of the PDAO Head, the PSB shall have one member who is either a permanent LGU employee with disability or a person nominated by the convenors to be an observer member of the PSB. The City Mayor shall appoint the PDAO from the list of nominees. The appointment order shall be submitted to the Civil Service Commission Regional Office (CSCRO) as provided by law and applicable Civil Service Commission (CSC) rules.

**Section 5. Funding.** The budgetary requirements of the PDAO shall be included in the City Government's Annual Plans and Budgets.

**Section 6. Separability Clause.** Should any provision, section or part of this Ordinance be declared as invalid by any court of competent jurisdiction, such judgment shall not affect or impair the remaining provisions, sections or parts hereof which shall continue to be in full force and effect.

**Section 7. Repealing Clause.** - Any ordinance in conflict with this Ordinance is hereby repealed and/or modified accordingly.

**Section 8. Effectivity.** This Ordinance shall take effect upon approval hereof by the Sangguniang Panlalawigan and after its publication at least once in a newspaper of general circulation in the Province of Cavite.
