AN ORDINANCE CREATING THE PADRE MARIANO GOMES AWARD TO BE BESTOWED ON INDIVIDUALS OR PRIVATE JURIDICAL ENTITIES THAT CONSISTENTLY ASSISTED THE CITY OF BACOOR, CAVITE IN VARIOUS CHARITABLE OR PHILANTHROPIC ACTIVITIES AND PROVIDING FUNDS FOR THE IMPLEMENTATION HEREOF.

WHEREAS, Fr. Mariano Gomes originally hailed from Bacoor, Cavite and served as its first Filipino parish priest until the day he was executed for crimes he did not commit by the Spanish colonial authorities in 1872 together with his fellow priests Jose Burgos and Jacinto Zamora.

WHEREAS, during his lifetime, Fr. Gomes devoted his life in the service of God by educating the young and by comforting the sick, the poor, and the oppressed without expecting anything in return.

WHEREAS, the generosity of spirit and selflessness of Fr. Gomes are admirable traits that every Bacooreño should possess or should aspire to possess.

WHEREAS, Section 16 of Republic Act No. 7160 [“the Local Government Code of 1991”] provides in part that local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among

WHEREAS, the creation of an award that gives due recognition to individuals and juridical entities that have a consistent track record of assisting the City Government in the conduct of charitable or philanthropic projects for the benefit of various demographic sectors in the City of Bacoor, Cavite shall ensure that the spirit of volunteerism and the habit of unselfishly helping those in need shall become a permanent fixture in the everyday life of every Bacooreño.

NOW THEREFORE, be it ordained by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite **THAT**:

SECTION 1. Creation of the Fr. Mariano Gomes Award.

The Mariano Gomes Award is hereby created and shall be conferred upon any individual or juridical entity—whether residing, operating, or doing business in the City of Bacoor, Cavite or not — who have consistently assisted the City Government in the holding of various charitable and philanthropic works or projects in the City of Bacoor, Cavite.

SECTION 2. Conferment of Award.

The said award shall be conferred by the City Mayor once every two years upon the recommendation of a selection committee to be comprised by the following:

The City Mayor, or his/her duly authorized representative as Chairperson;

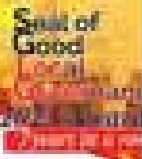
The Head of the Bacoor City Culture, History, Arts and Tourism office as Vice Chairperson;

As members:

1. The Head of the City Social Welfare and Development Office
2. The Chairperson of the Committee on Educations, Culture and Sports of the Sangguniang Panlungsod; and
3. The Local Economic and Investments Promotions Officer.

SECTION 3. Criteria.

The various criteria in the selection of the persons who shall be considered for conferment of the said award as well as the process for selection shall be determined by the members of the selection committee who are mandated to meet and to submit their recommendations for the approval

SECTION 4. Plaque of Recognition. Subject to availability of funds and pertinent government regulations, a plaque of recognition shall be awarded by the City Mayor to the awardee during ceremonies to be conducted within the City of Bacoor, Cavite.

SECTION 5. Implementing Rules and Regulations. The implementing rules and regulations of this Ordinance shall be prepared by the head of the Bacoor City Culture, History, Arts and Tourism office with the assistance of the City Legal Officer to be submitted for the approval of the City Mayor not later than ninety (90) working days following the date of effectivity hereof.

SECTION 6. Repeal. All ordinances, resolutions, or executive orders inconsistent or contradictory to the provisions of this Ordinance are hereby repealed or are modified accordingly.

SECTION 7. Separability. The provisions of this Ordinance not affected by an order issued by a competent court of law declaring parts hereof as void or unconstitutional shall remain valid and enforceable.

SECTION 8. Effectivity. This Ordinance shall become effective immediately after it has been posted on at least three (3) conspicuous places within the City of Bacoor, Cavite.
