**AN ORDINANCE CREATING VARIOUS POSITIONS IN THE DIFFERENT OFFICES/DEPARTMENTS OF THE CITY GOVERNMENT OF BACOOD AND PROVIDING APPROPRIATIONS THEREFOR IN THE ANNUAL BUDGET OF THE CITY GOVERNMENT OF BACOOD, CAVITE FOR FISCAL YEAR 2025.**

**Section 2. Effectivity.** --This Ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) other conspicuous places in the City of Bacoor not later than five (5) days after the approval thereof.

**Section 3. Separability.** -- Any provision of this Ordinance declared void by any court of law shall not affect the other provisions hereof not affected by such declaration.

**Section 4. Dissemination.** --The Sangguniang Panlungsod Secretariat is hereby directed to furnish the Office of the City Mayor, the Human Resources Development and Management Department, the Office of the City Budget Officer, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and all government offices concerned with copies of this ordinance immediately after its date of effectivity.
