AN ORDINANCE MANDATING THE OBSERVANCE BY ALL EMPLOYEES OF THE SANGGUNIANG PANLUNGSOD AND OFFICE OF THE VICE MAYOR OF THE VARIOUS PROVISIONS OF CITY ORDINANCE NO. 293-2023 AND PROVIDING GUIDELINES FOR THEIR COMPLIANCE THERETO.

WHEREAS, City Ordinance No. 293-2023 (the "20 MINUTES FOR HEALTHIER EMPLOYEES LEADS TO BETTER SERVICE" Ordinance) was approved by the Sangguniang Panlungsod on 26 July 2023 and aims to:

- Improve the health and well-being of 2.1 the City Government of Bacoor employees and personnel;
- 2.2 Decrease the percentage of the City Government of Bacoor employees and personnel who are hypertensive:
- 2.3 healthier employees personnel, improve the quality of services provided by the City Government.

WHEREAS, Section 4 of the said city ordinance provided the following guidelines for its implementation:

- "Section 4. Guidelines. This Ordinance shall be implemented based on the following guidelines:
 - 4.1 The Human Resources Development and Management Department (HRDMD) shall formulate a plan for the conduct of the daily 20-minute exercises based on the following parameters:

- The session in the morning may be conducted before or after 10:00 AM.
- The session in the afternoon may be conducted before or after 3:00 PM.
- d. Each session shall be for ten minutes only; and
- e. There must be two (2) sessions each day and must total 20 minutes.
- 4.2 The HRDMD shall be in charge of identifying, tapping, or procuring resource person/s who will manage and conduct the daily 20minute exercise.
- 4.3 The HRDMD shall be in charge of information dissemination and monitoring all of the City Government employees' and personnel's compliance with this Ordinance; and
- 4.4 The HRDMD shall ensure that public services will not be unduly disrupted or prejudiced; the personnel complement may be divided into such groups as may be necessary, which shall undertake such activities at different times of the day." (Underscoring supplied)

WHEREAS, the employees of the Sangguniang Panlungsod and the Office of the City Vice Mayor are assigned and report for work at the Bacoor Legislative and Disaster Resilience Building and not at the City Hall main building. Considering the distance between the BLDR Building and the City Hall main building, it is hard for the HRDMD to monitor the compliance of the employees of the SP and OVM to City Ordinance No. 293-2023. Moreover, a number of taxpayers have expressed their displeasure at the way the said ordinance is being implemented because it disrupts the delivery of public services.

WHEREAS, in view of the foregoing, a different set of guidelines must be established to ensure that the provisions of Sections 2 and 4 of City Ordinance No. 293-2023 shall be properly complied with by the employees of the SP and the OVM.



NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica, unanimously seconded by the Body, BE IT ORDAINED by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite THAT:

Section 1. Mandatory Guidelines for SP/OVM Employees. The following guidelines shall be complied with by all employees of the Sangguniang Panlungsod and of the Office of the Vice Mayor in the implementation of City Ordinance No. 293-2023:

- 1.1. Employees of the Sangguniang Panlungsod and the Office of the Vice Mayor who reports for work at the BLDR Building shall exercise in groups to be determined by the Sangguniang Panlungsod Secretary to be submitted to the HRDMD.
- 1.2. The said group exercises shall consist of calisthenics chosen by each depending on their age or health condition and shall be performed at their respective office/s. Each member of each group shall be given a chance to be the exercise leader each day. The SP Secretary shall approve the type of group exercises to be performed by each group. Provided that: each group shall be given the chance to change their exercise routines depending on the level of fitness of each member subject to the approval of the SP Secretary.
- 1.3. The SP Secretary shall designate a group leader for each group who shall be dutybound to videotape the compliance of each group member to this Ordinance and to City Ordinance No. 293-2023. Each videoclip shall be saved in a digital folder created for the said purpose for reference and periodic examination by the HRDMD.
- 1.4. To ensure that the delivery of public services shall not be disrupted, the said groups shall choose from among the following schedules when to conduct their group exercises:

Aside from the schedules mentioned above, NO OTHER SCHEDULE SHALL BE ALLOWED.

- 1.5. SP/OVM employees with existing health conditions that make it perilous for them to comply to City Ordinance No. 293-2023 or who perform work outside of the BLDR Building during the schedules mentioned above shall be exempted from compliance herewith.
- SP/OVM employees who refuse or who fail to 1.6. comply with these guidelines for no justifiable reason shall be held liable for insubordination based on pertinent civil service regulations and shall be meted with the appropriate penalty provided under City Ordinance No. 293-2023 and its implementing rules and regulations, if any.
- 1.7. Group exercises shall be immediately discontinued in case any member of the public is in need of assistance. The said group exercise shall be resumed after the public service required has been delivered. The delivery of public service MUST be given priority over compliance with this Resolution or with City Ordinance No. 293-2023.

Section 2. Amendment of Guidelines. The guidelines herein set forth may be amended by the City Vice Mayor based on the exigencies of public service and/or the health condition of particular employees of the Sangguniang Panlungsod or of the Office of the Vice Mayor.

HRDMD Monitoring. The HRDMD, conjunction with the SP Secretary, shall monitor the compliance



Section 5. Mandatory Check-up. – Immediately upon effectivity of this Ordinance, the HRDMD shall submit a list of employees and personnel with hypertension. Thereafter, such persons shall be required to undergo monthly check-ups to monitor the status of their hypertension.

Section 6. Reporting. – The HRDMD shall submit the following reports:

- 6.1 A report on the status of the 20-minute exercise activities, data on compliance, and penalties given, if any. This shall be submitted monthly or when required by the local chief executive.
- 6.2 A report on the compliance of the hypertensive employees and personnel with the monthly check-ups along with the status of their illness. This shall be submitted quarterly or when required by the local chief executive.
- 6.3 A bi-annual evaluation of the effect or effectiveness of the 20-minute exercise.

Section 7. Public Service Priority. – Nothing in this Ordinance shall allow any City Government of Bacoar employees or personnel to disregard their public duty to the residents of the City of Bacoar. Public Service shall remain the priority of all City Government of Bacoar employees or personnel.

Section 8. Strict Compliance. - Despite the preceding Section, no City Government of Baccor employees or personnel shall disregard this Ordinance. The HRDMD shall ensure compliance of all employees with this Ordinance.

Section 9. Penalty Clause. - Any employee or personnel of the City Government of Baccor who fails or refuses to comply with this Ordinance shall be penalized in accordance with the following:

- 9.1 Two (2) consecutive instances of noncompliance:
 - a. First instance verbal warning

- e. Fifth instance Suspension for two days with no pay.
- Succeeding instances add a day to the number of days for suspension.
- 9.2 The total of non-compliance per month is five (5) instances or more, regardless of whether consecutive or not:
 - a. First instance Written warning
 - Second instance Suspension for five days with no pay.
 - Third Instance Suspension for ten days with no pay.
 - d. Fourth Instance Suspension for fifteen days with no pay.
 - e. Fifth Instance Suspension for thirty days with no pay.
 - Sixth Instance Termination from employment pursuant to pertinent civil service regulations.
- 9.3 The cleansing period shall be after two (2) years from the occurrence of the violation or non-compliance.
- 9.4 The HRDMD may, upon approval of the local chief executive, suggest to the Sangguniang Panlungsod to revise penalties mentioned above based on a review of the manner by which this Ordinance was implemented.

Section 10. Repealing Clause. All other Executive Orders and issuances inconsistent with this Order are hereby repealed or modified accordingly.

Section 11. Separability Clause. If any provision of this Order shall be held invalid or unconstitutional, the remaining provisions not affected thereby shall remain in full force and effect.

Section 12. Effectivity. This ordinance shall take effect immediately after approval of the City Mayor.
