CITY ORDINANCE NO. 413-2024
Series of 2024

AN ORDINANCE PROVIDING AND CREATING A COMPREHENSIVE BARANGAY HIV AND AIDS TASK FORCE GROUP, INSTITUTIONALIZING PROGRAMS, PROJECTS, ACTIVITIES, OR OTHER PURPOSES AND APPROPRIATING FUNDS THEREOF.

WHEREAS, based on the Department of Health Epidemiology Bureau (DOH-ES) report in the April - June 2024 HIV & AIDS Surveillance of the Philippines (HASP), there are 5,321 new HIV infections, with young individual aged 15-24 years old accounting for 47% of all cases;

WHEREAS, data from the 2021 Young Adult Fertility and Sexuality Survey (YAFSS) revealed a concerning 19% decline among young Filipinos aged 15 to 24 who heard about HIV and AIDS compared to 1994, where awareness stood at 95%. Only one out of five young individuals had comprehensive knowledge of HIV and AIDS;

WHEREAS, the 1987 Philippine Constitution, under Sections 10-11, 15-16, and 18 of Article II, provides that "The State shall promote social justice all phases of national development; values the dignity of every human person and guarantees full respect for human rights; shall protect and promote the right to health of the people and instill health consciousness among them; shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature; and affirms labor as a primary social economic force, it shall protect the rights of workers and promote their welfare";

WHEREAS, the 1987 Philippine Constitution, under Section 13, Article II, provides that "the State shall recognize the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being and shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs";

WHEREAS, the 1987 Philippine Constitution, under Sections 20 and 23 of Article II, provides that "The State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments; and shall encourage non-governmental, community-based, or sectoral organizations that promote the welfare of the nation";

WHEREAS, Section 2 of RA No. 11166 that accordingly, the State shall:

"(a) Establish policies and programs to prevent the spread of HIV and deliver treatment, care, and support services to Filipinos living with HIV in accordance with evidence-based strategies and approaches that uphold the principles of human rights, gender-responsiveness, and age-appropriateness, including meaningful participation of communities affected by the country's HIV and AIDS situation";

"(b) Adopt a multi-sectoral approach in responding to the country's HIV and AIDS situation by ensuring that the whole government approach, local communities, civil society organizations (CSOs), and persons living with HIV are at the center of the process";

"(c) Ensure access to HIV and AIDS-related services by eliminating the climate of stigma and discrimination that surrounds the country's HIV and AIDS situation, and the people directly and indirectly affected by it";

"(d) Provides the legal framework for the prevention, treatment, care, and support services for persons living with HIV, as well as for the conduct of awareness campaigns and education programs to address the rising HIV cases in the country; and

"(e) Positively address and seek to eradicate conditions that aggravated the spread of HIV infection, which include poverty, gender inequality, marginalization, and ignorance";

WHEREAS, there is a recognition of the necessity for the Local Sanggunian to enact an ordinance that shall uphold the rights and ensure the promotion of general welfare of the society and their protection from acts, conditions, or influences that are prejudicial to their development, and which shall set the guidelines for ordinances pertaining to the grass-roots of our nation;

WHEREAS, Republic Act No. 10742 otherwise known as the "Sangguniang Kabataan Reform Act of 2015," and its amendment under Republic Act No. 11768 mandates the Sangguniang Kabataan (SK) to implement programs that promote the well-being of the youth, including health-related programs;

WHEREAS, there is an urgent need to intensify HIV awareness and prevention efforts among the youth who are identified as one of the vulnerable sectors;

WHEREAS, Republic Act No. 7160, also known as the Local Government Code of 1991, states that every Local Government Unit shall exercise powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, to realize the vision of providing and enabling safe, and friendly environment for improving the well-being of the community, there is a need to establish a Comprehensive Local HIV and AIDS Awareness Code that will uphold the rights of the individuals, ensure the promotion of their general welfare, and shield them from detrimental influences or circumstances hindering their development, which shall see the framework for ordinances pertaining to the affected community;

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by the rest of the City Council, **BE IT ORDAINED, AS IT IS HEREBY ORDAINED**, by the 5th Sangguniang Panlungsod in session assembled that:

**ARTICLE I
GENERAL PROVISIONS**

SECTION 1. TITLE. This ordinance shall be known as the "Barangay HIV and AIDS Task Force".

promote and protect their moral, spiritual, intellectual, social well-being. It inculcate in patriotism and nationalism and encourage the involvement in public and civic affairs.

In accordance with RA 11166 and RA 10742 as amended by RA 11788, all Sangguniang Kabataan (SK) Councils in the cities/municipalities are hereby mandated to include HIV awareness and prevention programs in their Comprehensive Barangay Youth Development Plan (CBVDP), Annual Barangay Youth Investment Plan (ABYIP), and Annual Budget.

SECTION 3. OBJECTIVES. This Ordinance aims to:

1. Strengthen the capacity of SK Councils in conducting HIV prevention programs.
2. Ensure that HIV awareness and education programs are integrated into SK plans and budgets.
3. Provide youth-friendly HIV prevention strategies, including but not limited to educational campaigns, peer counseling, testing services, and referral mechanisms for treatment.

SECTION 4. MANDATE. The SK Councils shall:

1. Integrate HIV awareness and prevention programs in their CBYDP, ABYIP, and Annual Budget.
2. Conduct activities and programs focused on HIV education and prevention, in partnership with relevant agencies such as the Department of Health (DOH), the Office of the City Health Services, non-government organizations, and youth organizations.
3. Allocate a portion of the SK Fund for the implementation of HIV-related activities, in accordance with the relevant provisions of RA 10742 and RA 11766.

SECTION 5. PROGRAM COMPONENTS. The HIV Awareness and Prevention Program shall include, but not be limited to, the following components:

1. **Educational Campaigns** — Conduct HIV education seminars, workshops, and campaigns targeting the youth sector.
2. **Peer Educator Training** — Train youth leaders and volunteers as peer educators who will disseminate accurate information on HIV prevention and treatment.

3. **HIV Testing and Counseling** — Collaborate with health institutions to facilitate access to voluntary HIV testing and counseling services for the youth.
4. **Awareness in Schools and Communities** — Integrate HIV awareness in school and community programs in partnership with educational institutions and barangay health workers.
5. **Anti-Stigma and Discrimination Campaigns** — Implement campaigns that aim to reduce stigma and discrimination against individuals living with HIV.

SECTION 6. PROGRAMS, PROJECTS, AND ACTIVITIES. The Local Government of Bacoor shall include in their annual investment plans programs, projects, and activities that will promulgate to HIV and AIDS Awareness Campaign. In the case of the Barangays, the respective Sangguniang Barangay and Sangguniang Kabataan shall include programs, projects, and activities aligned to the AIP of the City Government of Bacoor.

**ARTICLE II
BARANGAY HIV AND AIDS TASK FORCE**

SECTION 7.

a. CREATION. To ensure the wide and multi-sectoral participation in local governance, the Local HIV and AIDS Task Force in every barangay shall be created and shall have an official acronym of "BHATF" for brevity. The Task Force shall be headed by the concerned Sangguniang Kabataan Chairperson, co-chaired by the Health Center Physician/Midwife, and composed of representatives from barangay and youth committee on health, barangay and youth committee on social welfare and non-government organizations. The Task Force shall assist in the planning and execution of projects and programs of its member organizations, the Sangguniang Kabataan, the Sangguniang Barangay, and the Local AIDS Councils (LACs).

b. QUALIFICATION OF THE MEMBERS OF THE BHATF. A member of the BHATF must be a citizen of the Philippines, a resident of Bacoor City for not less than one (1) year immediately preceding the day of their membership to the Task Force. They must be able to read and write, Filipino, English, and must not have been convicted by final judgment of any crime involving moral turpitude.

c. COMPOSITION OF THE BHATF. The BHATF shall be composed of two (2) core members. The two (2) core

members shall be composed of the SK Chairperson and the City Health Officer. The following shall be the maximum allocation of representatives from each of the different sectors:

- Chairperson : SK Chairperson
- Co-Chairperson : Health Center Physician/Midwife
- Members : Barangay Committee on Health
- Barangay Committee on Social Welfare
- SK Committee on Social Inclusion and Equity
- Multi-Sectoral Non-Government Organization

d. THE TECHNICAL WORKING GROUP. The BHATF TWO shall be composed of the rest of the SK Council, Barangay Council Chairman for Health, health staff from Barangay Health Station, Peer Navigator, if available. The TWO shall provide administrative support, organize, prepare minutes of meetings and resolutions, make all necessary arrangements, handle the different aspects of technical, financial, legal and, in certain cases, the project management aspects.

e. CONVENING OF THE TASK FORCE. The Chairperson shall initially convene the Task Force and shall be given preference to preside over the meeting with the concurrence of the majority may call a meeting. In the absence of the Chairperson, the Co-Chairperson may convene and serve as the Pro-Tempore Presiding Officer of the said meeting.

f. MEETINGS AND QUORUMS. The Task Force shall schedule a meeting quarterly and as needed. However, if the Chairperson and/or the Co-Chairperson fails to convene the Task Force as scheduled, at least one-third (1/3) of the total membership may call for a meeting. In both instances, a written notice shall be sent either through traditional or non-traditional means, to all members setting the date, time, place, and agenda of the meeting which must be received at least two (2) days in advance. The presence of the majority (50% + 1) of all members shall constitute a quorum.

g. DUTIES AND FUNCTIONS. The Task Force shall have the following duties and functions:

1. Take the lead in planning and implementing HIV and AIDS awareness programs on various platforms.
2. Develop policies regarding related HIV and AIDS awareness and prevention programs.
3. Collaborate with other government and non-government organizations, community-based groups,

- and private organizations to help increase awareness and information of the youth by tapping the resources and expertise of said organizations.
4. Conduct peer education initiatives with the community, making use of peer-to-peer communication and volunteers as essential means of raising awareness.
 5. Develop Action Plan for the said HIV and AIDS response utilizing the Programs, Projects, and Activities (PPAs).
 6. Promote HIV screening and testing programs in collaboration with neighborhood health centers and licensed service providers.
 7. Provide the Local AIDS Council with regular updates on the Task Force's operations and advancement.

- h. ADVISORY GROUP.** The following shall be resource persons whom the BHATF may invite to shed light and advise the body on pertinent issues affecting the community:
- Barangay Chairperson
 - City Health Officer
 - Members of the Committee on Social Welfare and Development
 - Local Government Operations Officer
 - Local Youth Development Officer
 - City Social Welfare and Development Officer

i. MONITORING AND EVALUATION. The Office of the City Health Services, in coordination with the SK Federation and local health authorities, shall monitor and evaluate the implementation of this Ordinance. The SK Councils are required to submit Post Activity/Accomplishment Reports on the progress and outcomes of their HIV-related programs.

j. LOCAL HIV AND AIDS TASK FORCE FUNDING. Each SK Council is required to allocate sufficient funds from their Annual Budget for the implementation of the Awareness and Prevention programs, projects, and activities concerning HIV and AIDS, convening the meetings of the concerned BHATF, as well as its operations and effective functioning. The amount to be allocated shall be determined by the SK Council, subject to approval by the Sangguniang Barangay, and must comply with the provisions of RA 10742 as amended by RA 11768. All expenditures of these funds shall be subject to COA rules and regulations.

SECTION 8. APPROPRIATIONS - The Local Government of Bacoor shall appropriate an annual budget for the purpose of successful and efficient implementation of this ordinance.

SECTION 9. IMPLEMENTING RULES AND REGULATIONS — Within ninety (90) days from the effectivity of this ordinance, the members shall hold consultations, primarily with legal advisers and organizations. These consultations will determine effective ways and methods for the implementation of this ordinance and the crafting of Implementing Rules and Regulations.

SECTION 10. PENALTY CLAUSE - Non-compliance with the provisions of this Ordinance shall result in administrative sanctions against the SK officials involved, in accordance with the rules and regulations of the Sangguniang Kabataan Reform Act and relevant local laws.

SECTION 11. SEPARABILITY CLAUSE - If, for any reason/s, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts and provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 12. REPEALING CLAUSE - All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 13. EFFECTIVITY- This Ordinance shall become effective immediately after it has been published at least once in a newspaper of general circulation within the Province of Cavite and after it has been posted on three (3) conspicuous places within the City of Bacoor, Cavite.
