**AN ORDINANCE ABOLISHING FOUR (4) DENTIST 1 POSITIONS WITH CORRESPONDING SALARY GRADE 14 AND CREATING THREE (3) DENTIST 2 POSITIONS WITH CORRESPONDING SALARY GRADE 17 UNDER THE OFFICE OF THE CITY HEALTH SERVICES IN THE CITY GOVERNMENT OF BACOR TO BE APPROPRIATED IN THE SUPPLEMENTAL BUDGET OF THE CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2025.**
