AN ORDINANCE AMENDING SECTION 6 OF CITY ORDINANCE NO. 266-2023 AND GRANTING THE CITY MAYOR THE POWER TO GIVE DISCOUNTS TO PERSONS IN CRISIS SITUATIONS WITH DEPARTED RELATIVES LYING IN STATE AT THE MOLINO CEMETERY SITUATED AT BARANGAY MOLINO 2, BACODR CITY, CAVITE.

WHEREAS, City Ordinance No. 266-2023 was unanimously approved by the Sangguniang Panlungsod in order to provide a pricing system at the Molino Cemetery situated in Barangay Molino 2, City of Bacoor, Cavite that will enable the City Government to finance its continued operation.

WHEREAS, despite the efforts of the Sangguniang Panlungsod to make the service and rental fees for the use of the various facilities of the Molino Cemetery comparable to the rates being charged by other public cemeteries being operated by local governments near the City of Bacoor, reliable reports were received by the City Mayor, Hon. Strike B. Revilla, which indicated that economically challenged residents of the City still cannot afford to pay the said fees.

WHEREAS, in view of the said reports, the City Mayor requested the Sangguniang Panlungsod to review City

Ordinance No. 266-2023 and study a way by which some form of financial relief may be granted by the City Government to City residents mired in penury or who may have been victims of severe man-made or natural calamities which prevent them from paying the fees mandated by the said Ordinance.

WHEREAS, the Sangguniang Panlungsod deliberated on the City Mayor's request and decided to amend the said Ordinance.

NOW THEREFORE, be it ordained by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite THAT:

Section 1. Title. This Ordinance shall be known and referred to as the "Molino Cemetery Special Discount Ordinance".

Section 2. Amendment of Section 6 of City Ordinance No. 266-2023. Section 6 of City Ordinance No. 266-2023 is hereby amended and shall read as follows:

"Section 6. Discounts. The City Mayor is hereby empowered to give discounts on all fees indicated above to registered voters of the City of Bacoor, holders of a Special Bacoor Resident (SBR) Card, incumbent or former city or barangay officials, active or retired city government and/or barangay personnel, or the dependents of the said persons who was/were certified by the City Social Welfare and Development Department and by the Punong Barangay where the said person/s reside to be suffering from extreme poverty or who may have been a victim of a severe man-made or natural disaster as maybe defined in the implementing rules and regulations of this Ordinance. **Provided that:** the said discount should not exceed 50% of the fees provided above and the discounted fees should be paid in cash or on an installment basis for a period not exceeding one (1) calendar year from the date a written request for a discount was received either by the CSWD or by the Office of the City Mayor.

Section 2. Columbarium Rental Fees; Rental Period. The surviving relatives of a deceased whose cremains are interred in a columbarium vault within the Molino Cemetery shall pay a rental fee of:

Row 2	P500.00

The said rental fees shall be paid for five (5) years commencing on the date of execution of the Niche/Vault Rental Agreement between the said person/s and the city government to be represented by the City Mayor. Failure to pay the said rental fees despite receipt of a formal demand from the Office of the City Mayor shall result in the termination of the agreement and the return of the cremains of the deceased to his/her surviving relatives. Only Bacoor City residents shall be allowed to rent a columbarium vault at the Molino Cemetery.

Section 3. Extension of Rental Period; Disposal of Cremains. Unless extended by way of a new Niche/Vault Rental Agreement between the relatives of the deceased and the city

government, the said remains shall be returned to the relatives of the deceased upon the expiration of the 5-year period mentioned above. In case the agreement is extended, the extension shall not exceed five (5) additional years and the rental fee shall be increased by 100% per year based on the rental fees mentioned in Section 2 hereof. After the expiration of the extension of the rental period, the remains shall be returned to the surviving relatives of the deceased. If the deceased no longer have any relative/s residing within the City of Bacoor or if the surviving relatives of the deceased refuse to receive the remains despite due notice, the remains shall be interred with dignity at a burial site within the Molino Cemetery.

Section 4. Procedures for Use of the Cremation Services/Columbarium. The following procedures must be complied with in order to avail of the cremation and columbarium services of the Molino Cemetery:

4.1. The relative/s of the deceased must submit the Cremation Application Form (CAF) to the Office of the City Mayor. The CAF must contain the following personal data of the deceased: name, age, complete address, and the cause/date/place of death of the deceased. The Death Certificate of the deceased must be attached to the CAF.

4.2. To avail of discounted rates mentioned above, residents must submit a Certificate of Residency from the Barangay where the deceased resided immediately prior to his/her death.

4.3. The relative/s of the deceased must obtain an Order of Payment from the City Administrator, or any duly authorized representative of the City Mayor, which must state the amount of fees to be paid to the city government.

4.4. The relative/s of the deceased must pay the fees stated in the Order of Payment at the City Treasurer's Office.

4.5. After payment of the said fees and the issuance of the corresponding official receipt by the City Treasurer's Office, the relatives of the deceased must obtain a Cremation Permit from the Office of the City Administrator, or any duly authorized representative of the City Mayor. The Cremation Permit shall indicate the schedule of the cremation and the number of the niche/vault where the remains shall be interred. In case the relatives of the deceased choose to inter the remains of the deceased somewhere else, the urn and remains of the deceased shall be given to the relatives of the deceased after the latter executes an Affidavit of Waiver, Release, and Quitclaim.

Section 5. Rental for Bereavement Room and Chapel. The following rental fees shall be collected for the use of the bereavement area and chapel at the Molino Cemetery:

Section 6. Discounts. Registered voters of the City of Bacoor, holders of a Special Bacoor Resident (SBR) Card, incumbent city or barangay officials, city government and/or barangay personnel, or the dependents of the said persons, who availed of the reduced crematorium service fees mentioned in the Section 1 shall no longer be entitled to other legally-mandated discounts such as those for senior citizens and for persons with disabilities. Registered voters of the City of Bacoor, holders of a Special Bacoor Resident (SBR) Card, incumbent city or barangay officials, city government and/or barangay personnel, or the dependents of the said persons, who insist on availing the said discounts shall be required to pay the crematorium service fees provided for registered voters of other local government units, none SBR Card holders, or for none residents of the City of Bacoor.

Section 7. Implementing Guidelines. The City Legal Officer is hereby directed to formulate the implementing guidelines of this Ordinance and to submit the same to the City Mayor not later than sixty (60) days following the effectivity date hereof.

Section 8. Effectivity Date. This Ordinance shall take effect immediately after it has been published at least once in a newspaper of general circulation in the City of Bacoor, Cavite.

Section 9. Repeal. All city ordinances and resolutions inconsistent with the provisions hereof are hereby repealed.

Section 10. Separability. In case a provision of this Ordinance is declared void by a court of law, the remaining provisions hereof not affected by the said declaration shall remain valid.
