AN ORDINANCE AMENDING AND MODIFYING CERTAIN SECTIONS OF CITY ORDINANCE NO. CO 47-2019, OTHERWISE KNOWN AS THE "ROAD CLEARING ORDINANCE OF THE CITY OF BACOR".

WHEREAS, on 11 November 2019, City Ordinance No. CO 47-2019, entitled: "AN ORDINANCE AUTHORIZING THE CLEARING OF ALL SIDEWALKS, ROADS, BRIDGES, AND OTHER PUBLIC THOROUGHFARES IN THE CITY OF BACOR, CAVITE, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF," was approved by the Sangguniang Panlungsod of the City of Bacoor, Cavite;

WHEREAS, the 2020 Socio-Ecological Profile of the City of Bacoor listed 18 National and Provincial Roads and 117 City Roads, including the Solidarity Routes, across the entire city;

WHEREAS, on 12 January 2023, City Ordinance No. 255-2023, also known as the "Expanded Solidarity Route Ordinance" was approved, and additional Solidarity Routes were included;

WHEREAS, certain sections of City Ordinance No. 255-2023 were amended in November 2023 upon approval of City Ordinance No. 322-2023, and additional solidarity routes were established in some subdivisions;

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2024-053, mandating the nationwide implementation of the barangay road clearing operation under the Bagong Pilipinas Program, in relation to DILG Memorandum Circular No. 2022-085, providing guidelines in the implementation of road clearing operations in the new-normal;

WHEREAS, the Office of the City Mayor recommended to the Sanggunian to review and amend City Ordinance No. 47-2019, taking into account the inclusion of new solidarity routes, identification of city roads, and recent DILG issuances on road clearing.

NOW, THEREFORE, be it ordained by the 5th Sangguniang Panlungsod THAT:

SECTION 1. Section 2 of City Ordinance No. CO 47-2019 shall read as follows:

"Section 2. Purposes. This Ordinance is intended to achieve the following:

- 2.1. Effectively implement DILG Memorandum Circular No. 2019-01, which mandates local government units to reclaim public roads, sidewalks, alleys, and other public thoroughfares and clear them of illegal structures, along with other subsequent DILG directives instructing the LGUs to conduct road clearing under the Bagong Pilipinas Program;
- 2.2. Improve the flow of pedestrian and vehicular traffic in various public thoroughfares within the City of Bacoor by reducing road obstruction on the road including illegal parking on most city roads;
- 2.3. Balance vehicular volume vis-a-vis the available road capacity to provide acceptable conditions to the travelers within the City of Bacoor; and
- 2.4. Create a system of accountability for the effective implementation of this Ordinance."

SECTION 2. Section 5 of the City Ordinance No. 47-2019 shall read as follows:

"Section 5. Ban on Parking on All Primary and Secondary Roads including Solidarity Routes. The parking of all types of motor vehicles on the following roads is hereby prohibited:

after the effectivity of this Ordinance shall automatically be covered by the prohibition on parking under this Section."

SECTION 3. A new Section shall be inserted as the new Section 6 of City Ordinance No. 47-2019:

"Section 6. Public Information and Signages. The BTMD is hereby directed to install appropriate no-parking signs on all roads covered under this Ordinance. Signage must be clear and visible to all drivers. The City Information and Community Relations Department shall assist in the public dissemination of this Ordinance. All Barangays in the City of Bacoor shall aid in installing the no-parking signs and disseminating public information in their respective jurisdictions."

SECTION 4. Renumbering of Succeeding Sections. As a consequence of the insertion of the foregoing provision, all succeeding sections of City Ordinance No. 47-2019 are hereby renumbered.

SECTION 5. Repeal. All ordinances, resolutions, implementing rules and regulations, and executive orders related to this Ordinance are considered expressly repealed or modified.

SECTION 6. Separability. In case any provision of this Ordinance is declared void by a court of law, the remaining provisions of this Ordinance not affected by the said judicial declaration shall remain valid and enforceable.

SECTION 7. Effectivity. This Ordinance shall become effective upon its approval and after it has been published at least twice in a newspaper, of general circulation, and posted in at least three (3) conspicuous places within the City of Bacoor. A copy of this Ordinance shall be submitted to the UP-ONAR before its effectivity.

Section 3. Cancellation of Permits. All permits – whether express or implied – issued in favor of private natural or juridical persons for the use of public roads, sidewalks, and other public thoroughfares within the City of Bacoor are hereby cancelled.

Section 4. Authority to Remove Obstructions. The Bacoor Traffic Management Department (BTMD), the City Inspection and Compliance Unit (CICU), and all barangay officials in the City of

Section 6. Authority to Tow or Clamp Illegally Parked Motor Vehicles. The BTMD is hereby empowered to tow or clamp all motor vehicles illegally parked in the public roads enumerated in Section 5 hereof and to impound the same pursuant to the relevant provisions of the Bacoor Traffic Code.

Section 7. Penalties.

(a) All natural persons who violate this Ordinance shall be meted with the following penalties:

First Offense:	Fine of P3,000.00;
Second Offense:	Fine of P4,000.00;
Third Offense:	Fine of P5,000.00 and imprisonment of not less than thirty (30) days and not more than sixty (60) days.

(b) All barangay and city government officials who violate this Ordinance shall be meted with the following penalties:

First Offense:	Fine of P3,000.00 and suspension with no pay for ten (10) successive working days;
Second Offense:	Fine of P4,000.00 and suspension with no pay for thirty (30) successive working days;

Third Offense:

Fine of P5,000.00 and termination of employment or, in the case of elected public officials, removal from office.

Section 8. Separability Clause. In case any provision of this Ordinance is found void by a court of law, the other provisions hereof not affected by such declaration shall remain valid.

Section 9. Repeal Clause. All ordinances, resolutions, executive orders, memoranda, or circulars not consistent with the provisions of this Ordinance are hereby repealed, modified, or amended.

Section 10. Effectivity Clause. This Ordinance shall become effective fifteen (15) days after it has been published at least twice in a newspaper of general circulation, posted on at least three (3) conspicuous places within the City of Bacoor, and after the Sangguniang Panlalawigan has approved it
