**CITY ORDINANCE NO. 434- 2025
SERIES OF 2025**

AN ORDINANCE REVISING CITY ORDINANCE NO. 420-2025 WHICH REQUIRED THE PAYMENT OF A SOCIALIZED FEE FOR THE RECTIFICATION OF SIMULATED BIRTHS IN THE CITY OF BACOR, CAVITE.

WHEREAS, Republic Act No. 11222 (the "Simulated Birth Rectification Act") authorized the rectification of the simulated birth of a child where the simulation was done in for the best interest of the child and that the said child has been consistently considered and treated by the person/s who simulated such birth as his/her own son or daughter.

WHEREAS, Section 27 of the Implementing Rules and Regulations of the said law authorized the Local Civil Registrar of all local government units to collect a socialized fee of P1,000.00 from those who shall avail of the administrative adoption proceedings permitted under RA 11222.

WHEREAS, the Local Government Code of 1991 provides each local government unit shall have the power to create its own sources of revenues and to levy taxes, fees and charges subject to such guidelines and limitations as the Congress may provide, consistent with the basic policy of local autonomy.

WHEREAS, City Ordinance No. 420-2025 (entitled: "AN ORDINANCE REQUIRING THE PAYMENT OF A SOCIALIZED FEE FOR THE RECTIFICATION OF SIMULATED BIRTHS IN THE CITY OF BACOR AND PROVIDING PENALTIES FOR VIOLATION HEREOF") was approved by the Sangguniang Panlungsod on 13 January 2025 but it was returned to the City Council by the Sangguniang Panlalawigan for revision.

WHEREAS, in compliance with the recommendations of the Sangguniang Panlalawigan, the instant Ordinance was

NOW THEREFORE, be it ordained by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite that:

Section 1. Title. This Ordinance shall be known as the "**Revised Simulated Birth Rectification Ordinance of Bacoor**".

Section 2. Collection of Socialized Fee. The Local Civil Registrar, through the City Treasurer's Office, is hereby authorized to collect a socialized fee of P1,000.00 from any person who has availed of the administrative adoption proceedings provided under Republic Act No. 11222 (the "Simulated Birth Rectification Act") and its implementing rules and regulations. A corresponding invoice shall be issued by the City Treasurer's Office in favor of the person who shall pay the said amount. Provided that: the said fee shall be waived in favor of indigents residing in the City of Bacoor who have presented competent proof of such indigency issued by the City Social Welfare and Development Office.

Section 3. Effectivity. This Ordinance shall become effective immediately after it has been published at least once in a newspaper of general circulation in the City of Bacoor, Cavite.

Section 4. Repeal. All ordinances, resolutions, executive orders, and regulations inconsistent with this Ordinance are hereby repealed or modified accordingly.
