CITY ORDINANCE NO. 440-2025

AN ORDINANCE DECLARING (1) THE "BACOR HEROES TOWER" AS THE OFFICIAL NAME OF THE SOON TO RISE STRUCTURE AT THE MABOLO FREEDOM PARK AND (2) DECLARING "MABOLO FREEDOM PARK" AS THE OFFICIAL NAME OF THE PLAZA SITUATED AT BARANGAY MABOLO, CITY OF BACOR, CAVITE.

WHEREAS, Section 13 of Republic Act No. 7160 (the "Local Government Code of 1991") empowered component cities such as the City of Bacoor, Cavite to name various public places within its jurisdiction.

WHEREAS, since the last world war, the Mabolo Plaza has been a public thoroughfare beloved by the residents of Barangay Mabolo and has been a mute witness to various events that unfolded in the annals of Bacoor's history.

WHEREAS, Batas Pambansa 880 empowered local governments through a ordinance to designate public places within its boundaries as "freedom parks" which may serve as spaces where events, community gatherings and even demonstrations may be held in order to foster civic engagement and promote freedom of expression.

WHEREAS, the Office of the City Mayor formally requested the Sangguniang Panlungsod to pass an ordinance naming the soon-to-rise structure on Mabolo Plaza as the "Bacoor Heroes Tower" and renaming the said plaza as the "Mabolo Freedom Park".

WHEREAS, the Bacoor Heroes Tower will not only serve as a constant reminder to the young about the heroism and sacrifices made by generations of Bacooreños long gone in defense of freedom but will also serve as an extension office of the Bacoor

WHEREAS, renaming the Mabolo Plaza as the "**Mabolo Freedom Park**" shall formalize the designation of the said place as a hallowed ground of liberty where all Bacooreños may express their opinions freely.

NOW THEREFORE, be it ordained by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite that:

Section 1. The Bacoor Heroes Tower. The three-story building soon to rise on the public space erstwhile known as the Mabolo Plaza situated in Barangay Mabolo, City of Bacoor, Cavite shall hereafter be officially known as the "**BACOR HEROES TOWER**".

Section 2. The Mabolo Freedom Park. The public space erstwhile known as the Mabolo Plaza situated in Barangay Mabolo, City of Bacoor, Cavite shall hereafter be officially known as the "**MABOLO FREEDOM PARK**".

Section 3. Maintenance of the Bacoor Heroes Tower and the Mabolo Freedom Park. The Bacoor Heroes Tower and the Mabolo Freedom Park shall be jointly managed and maintained by the BTMD, BDRRMD, the City Engineering Office. The said departments shall implement policies in coordination and cooperation with one another to ensure that the historical significance, cleanliness, and orderliness of the Bacoor Heroes Tower and the Mabolo Freedom Park shall be maintained at all times.

Section 4. Repeal. All ordinances and executive orders that are inconsistent with this Ordinance are hereby repealed and/or modified accordingly.

Section 5. Implementing Rules and Regulations. The aforementioned departments shall, with the assistance of the City Legal Services Office, submit for the review and approval of the City Mayor the implementing rules and regulations of this Ordinance not later than sixty (60) calendar days from the date of effectivity hereof.

Section 6. Effectivity. This Ordinance shall take effect immediately after copies thereof has been posted on the bulletin board near the entrance of the Bacoor City Hall, the Bacoor
