WHEREAS, on 26 August 2025, the aforementioned ordinance was referred to the Committee on Social Services and to the Committee on Rules, Privileges, Laws and Ordinances;

WHEREAS, the said committees conducted a committee hearing and they recommended to approve the said amendment;

NOW THEREFORE, be it ordained by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite, that:

Section 1. Section 7 of City Ordinance No. 358-2024 is hereby amended to read as follows:

"SECTION 7. WHERE IT MAY BE AVAILED. The R.E.V.I.L.L.A. Action Center shall have its main office at the Bacoor Government Center, Bayanan, Bacoor City, six (6) offices and one (1) sub-office that will serve six (6) clusters of barangays that were grouped together based on the population and location of the said barangays.



WHEREAS, Section 455 (a) of the Local Government Code (LGC) provides that the City Mayor, as the local chief executive of the city government, is empowered to exercise such powers and perform such duties and functions:

WHEREAS, the City Mayor has the duty to ensure that all executive officials and employees of the city faithfully discharge their duties and functions provided by law and the Local Government Code under Section 455 (b)(1)(x) of the same Code:


WHEREAS, the City Mayor must ensure the delivery of basic services and the provision of adequate facilities according to 455 (b) (4) of the same Code:

WHEREAS, Section 458 (a)(1)(viii) of the Local Government Code provides that the Sangguniang Panlungsod has the power to enact an ordinance to determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the city government:

WHEREAS, it also has the power to pass an ordinance to formulate policies and adopt measures mutually beneficial to the elderly and the community; provide incentives for nongovernmental agencies and entities and, subject to the availability of funds to support programs and projects for the benefit of the elderly:

WHEREAS, Section 17 of the Local Government Code empowers the Local Government Units (LGUs) to execute necessary, appropriate, and incidental provisions of the basic services and facilities, including social welfare services;

WHEREAS, the City Government of Bacoor, through the leadership of the City Mayor - Hon. Strike B. Revilla, envisions a local government that is responsive and empathic to the needs of the residents of the City of Bacoor, most especially the marginalized sector of the City: the elderly, the persons with disabilities, the solo-parents, and the underprivileged.

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Bacoor, Cavite, that:

Section 1. Short Title - This Ordinance shall be known as the "Mayor's Socialized Benefits for Residents (MSBR) Committee Ordinance of 2024"

Section 2 CREATION OF THE MAYOR'S SOCIALIZED BENEFITS FOR RESIDENTS (MSBR) COMMITTEE - The Mayor's Socialized Benefits for Residents Committee is hereby created and will be manned by concerned offices / agencies that provides various social programs and services that respond IMMEDIATELY to the issues and concerns of the people in the community.

Section 3. DUTIES AND RESPONSIBILITIES OF THE MSBR COMMITTEE - The MSBR Committee shall have the following powers and duties:

Section 5. MSBR provides immediate response - The MSBR shall implement immediate services under the STRIKE Program to the residents of Bacoor City, as follows:

STRIKE Program - Sustainable service Towards truly Responsive and Immersive social service program which is a Key to a more progressive city for Every Bacoareños.

- 1. Strike sa Kalusugan All those Health and Wellness programs, projects, and services that are not available or covered by the City Health Office, CSWD to be augmented/extended through the MSBR.
- 2. Strike Sa Kaalaman activities of the City Government intended for immediate mass information dissemination or call for action which aim at capacitating LGU partners, NGO's.
- 3. Strike Sa Karapatan activities of the City Government intended to attend to the needs of less fortunate families and individuals not only confined to legal services and/or case related impediments that need immediate actions but also social inclusion activities.
- 4. Strike sa Kaayusan initiatives or innovative projects/services of the City Government intended to enhance/heighten public order, security and the safety of every Bacooreños.
- Strike sa Kabuhayan -barangay-based activities to create income-aeneratina opportunities as well as support to food security efforts of the LGU.

SECTION 12. REPEALING CLAUSE. All local ordinances, executive orders, resolutions, memoranda, regulations, or part thereof in conflict or inconsistent with any provisions of this Ordinance shall be considered hereby revoked and/or modified accordingly.
