CITY ORDINANCE NO. 467-2025 Series of 2025

AN ORDINANCE MANDATING THE MONTHLY UPDATING OF ALL NEGATIVE LISTS BEING MAINTAINED BY VARIOUS DEPARTMENTS OF THE CITY GOVERNMENT OF THE CITY OF BACOOR, CAVITE AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

WHEREAS, Section 8 (b) (1) of Republic Act No. 10160 (the "Charter of the City of Bacoor") authorized the City Mayor to exercise those powers expressly granted to him by law, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for the efficient and effective governance of the City, and those which are essential to the promotion of the general welfare.

WHEREAS, government officials have the duty to uphold and enforce the law as mandated by the 1987 Constitution and Republic Act No. 6713 (the "Code of Conduct and Ethical Standards for Public Officials and Employees").

WHEREAS, Republic Act No. 11032 (the "Philippine Ease of Doing Business Act") and its implementing guidelines mandate local government units to institutionalize reforms that will speed up the process of starting a new business or in running an existing business.

WHEREAS, the various departments of the City Government are mandated to maintain a list of the names, addresses, and other particulars of natural or juridical persons who have violated various laws, city ordinances, and government regulations so that the said individuals can be prevented from committing more offenses or be held accountable for the legal infractions they may have committed. The said lists are also known as "negative lists".

WHEREAS, after a series of consultative meetings with various stakeholders, the City Mayor, Honorable Strike B. Revilla, discovered that the heads of many departments of the

City Government have not regularly updated the said negative lists resulting in the ineffective implementation and enforcement of various laws, ordinances, and government reaulations.

WHEREAS, the City Mayor proposed to the Sangguniang Panlungsod to approved an ordinance that will require City Government heads to update the negative lists being maintained by their respective offices not later than the last working day of every month.

WHEREAS, the said proposed ordinance was submitted to the Sangguniang Panlungsod and was subjected to a series of public hearings attended by City Government department heads and other stakeholders.

WHEREAS, after thorough deliberation on the said proposed ordinance, the members of the 6th Sangguniana Panlungsod unanimously decided to approve the same in order to strengthen the rule of law in the City of Bacoor.

NOW THEREFORE, be it ordained by the 6th Sangguniang Panlungsod that:

Section 1. Title. This ordinance shall be known as "Negative List Updating Ordinance of the City of Bacoor".

Section 2. Mandatory Updating of Negative Lists. All department heads and acting department heads under the Office of the City Mayor are hereby mandated to update not later than the last working day of every month the list of the names, addresses, and other particulars of natural or juridical persons who have violated various laws, city ordinances, and government regulations being implemented by the said departments. The said list shall be referred to hereafter as the Negative List. Provided that is the last working day of each month is suspended by the government for whatever reason, the duty of the said departments heads or acting department heads shall be carried out on the next working day. Provided further that: the implementation of this Ordinance shall be done with due regard to the applicable provisions of the Data Privacy Act (Republic Act No. 10173). Provided lastly that: the Implementing Rules and Regulations of this Ordinance shall provide a mechanism on how and when the name of a natural or juridical person should be added or removed from the Negative List.

Section 3. Departmental Integration of Negative Lists. The E-Governance Department is given thirty (30) working days within which to integrate the Negative Lists of all departments covered by this Ordinance and make possible the seamless use of all data included in the said list in the effective

government regulations. Section 4. Development of Data Analytics System. The

implementation and enforcement of all laws, ordinances, and

E-Governance Department is hereby mandated to develop a system using data culled from the said Negative Lists that will enable the City Mayor and the Sangguniang Panlungsod to formulate ordinances, regulations, policies, procedures, or processes that will strengthen the rule of law in the City of Bacoor, Cavite.

Penalties. Any City Government employee Section 5. or department head who violates this Ordinance shall be held administratively liable pursuant to pertinent civil service regulations.

The imposition of any administrative penalty against the said employees or department heads shall not preclude the filing of the appropriate criminal case against any person who violates any provision of this Ordinance or any related law or city ordinance.

Section 6. Implementing Rules and Regulations. The City Legal Officer, in consultation with the heads of the various departments of the City Government under the Office of the City Mayor, including the Fire Marshall and the Chief of Police of the City of Bacoor, is mandated to submit the implementing rules and regulations of this Ordinance for the review and approval of the City Mayor not later than sixty (60) calendar days following the effectivity date hereof.

Section 7. Repeal. All ordinances, resolutions, executive orders, and other local issuances that are inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.

Separability. In case any provision of this ordinance or of its implementing rules and regulations are declared void by a court of law, the remaining provisions hereof shall remain valid and enforceable.

Section 9. Effectivity. This Ordinance shall take effect immediately after it has been published in a newspaper of general circulation in the City of Bacoor, Cavite and after it has been posted in at least three (3) conspicuous places within the City of Bacoor, Cavite.


