AN ORDINANCE FURTHER AMENDING SECTION 3 OF CITY ORDINANCE NO. CO 319-2023 SERIES OF 2023 AND SECTION 1 OF CITY ORDINANCE NO. 29-2019, IN RELATION TO CITY ORDINANCE NO. CO 24-2014 SERIES OF 2014, ALSO KNOWN AS "AN ORDINANCE GRANTING A FREE MOVIE PRIVILEGE TO ALL BACOR SENIOR AND DISABLED CITIZENS 2014".

WHEREAS, the Sangguniang Panlungsod of Bacoor enacted City Ordinance No. CO 24-2014, otherwise known as "An Ordinance Granting a Free Movie Privilege to all Bacoor Senior and Disabled Citizens 2014", a social service legislation designed to promote the welfare and enjoyment of Senior Citizens (SC) and Persons with Disabilities (PWDs), which was duly passed on 4 September 2014;

WHEREAS, the Sangguniang Panlungsod of Bacoor enacted City Ordinance No. CO 29-2019, Series of 2019, entitled "An Ordinance Amending Sections 2 and 3 of City Ordinance No. CO 24-2014, also known as 'An Ordinance Granting a Free Movie Privilege to all Bacoor Senior and Disabled Citizens 2014, thereby refining and strengthening the provisions of the original ordinance to further promote the welfare and enjoyment of senior citizens (SCs) and persons with disabilities (PWDs);"

WHEREAS, the Sangguniang Panlungsod of Bacoor enacted City Ordinance No. CO 319-2023, Series of 2023, entitled "An Ordinance Further Amending City Ordinance No. CO 24-2014 (An Ordinance Granting a Free Movie Privilege to all Bacoor Senior and Disabled Citizens 2014) in Relation to City Ordinance No. 29-2019 Series of 2019," thereby introducing additional refinements to strengthen and expand the implementation of the free movie privilege

**WHEREAS**, the City Mayor, Hon. Strike B. Revilla, formally requested the Sangguniang Panlungsod of Bacoor to enact an ordinance further amending Section 3, paragraph c, of City Ordinance No. CO 319-2023, Series of 2023, by replacing the birthday celebration of the City Mayor of Bacoor as the basis for entitlement of special beneficiaries under the Libreng Sine program, with August 01 of each year, in commemoration of the promulgation of Republic Act (R.A.) No. 12073;

**WHEREAS**, Republic Act No. 12073, otherwise known as the Bacoor Assembly Act of 1898, officially declares August 01 of every year as "Araw ng Paglalathala at Pagtatanyag ng Kasarinlan ng Pilipinas", in commemoration of the historic assembly held in Bacoor that proclaimed and affirmed Philippine independence;

**WHEREAS**, Teachers' Day in the Philippines is celebrated on October 5 of each year, coinciding with World Teachers' Day, to honor the contributions of educators to society and to appreciate their dedication and commitment in educating the youth and fostering a love for learning.

**NOW THEREFORE**, upon motion of Hon. Simplicio G. Dominguez, **BE IT ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite, THAT:

**Section 1. Amendment of Section 1, City Ordinance No. CO 29-2019, Series of 2019.** Section 1 of City ordinance No. CO 29-2019, Series of 2019 is hereby amended and shall henceforth read as follows:

"Section 2. Scope. This Ordinance shall only apply to all cinema operators and establishments within the City of Bacoor and may only be availed of once a day every Monday by the senior citizens and persons with disabilities who are bona fide residents of the City of Bacoor, Province of Cavite, as evidenced by the Electronic Special Bacoor Residents (E-SBR) Card issued by the City Government of Bacoor.

"Section 4. Special Beneficiaries. The beneficiaries of the Free Movie Privilege may be extended to different classes or groups of individuals who are bona fide residents of the City of Bacoor in celebration or commemoration of any national or local events, subject to the availability of funds, as may be determined and approved by the Parties. The Special Beneficiaries, excluding Senior Citizens and Persons with Disabilities, are entitled to the benefits of this privilege only once (1) per year upon presentation of their respective **Electronic-** Special Bacoor Residents (E-SBR) Card. The City Mayor has the sole authority to identify these Special Beneficiaries. Every Special Beneficiary is entitled to the privilege of this Ordinance on the following dates only:

a. Bacoor Cityhood Anniversary is celebrated every June 23 of each year;

b. Bakood festival is celebrated every last Sunday **of September** each year;

c. **Araw ng Paglalathala at Pagtatanyag ng Kasarinlan ng Pilipinas, as declared under Republic Act No. 12073, otherwise known as the Bacoor Assembly Act of 1898, shall be celebrated every August 01 of each year;**

d. **Teachers' Day Celebration is celebrated every October 05 each year; and**

e. Plebiscite celebration to be commemorated every July 29 each year.

The above-mentioned is not exclusive. The City Government of Bacoor, through the City Mayor, may include additional events subject to the availability of funds.

WHEREAS, the Sangguniang Panlungsod passed City Ordinance No. 24-2014 ("An Ordinance Granting a Free Movie Privilege to all Bacoor Senior and Disabled Citizens 2014"), a social service legislation intended for the benefit of senior citizens (SC) and persons with disabilities (PWD), on 4 September 2014.

WHEREAS, the Sangguniang Panlungsod passed City Ordinance No. 29-2019 ("An Ordinance Amending Sections 2 and 3 of City Ordinance No. CO 24-2014") on 30 September 2019 and gave additional privileges to the senior citizens and persons with disabilities.

WHEREAS, the City Mayor, Hon. Strike B. Revilla, formally requested the Sangguniang Panlungsod to pass an ordinance further amending City Ordinance No. 24-2014 as amended by City Ordinance No. 29-2019.

NOW THEREFORE, upon motion of Hon. Rogelio Nolasco and Hon. Simplicio Dominguez, **BE IT ORDAINED** by the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, Cavite, **THAT:**

**Section 1.** City Ordinance No. 24-2014 as amended by City Ordinance No. 29-2019 and by this Ordinance shall henceforth be known and referred to as the "**Libreng Sine Ordinance of Bacoor**".

**Section 2.** Section 3 of City Ordinance No. 24-2014 as amended by City Ordinance No. 29-2019 is hereby amended and shall henceforth read as follows:

**"Section 3. Free Cinema Admission.** – All senior citizens and persons with disabilities within the scope provided under Section 2 hereof may be entitled to free cinema admission once a day every Monday to be subsidized by the City Government of Bacoor, Cavite. Qualified senior citizens and persons with disabilities may only avail of the said privilege once (1) per week."

**Section 3.** City Ordinance No. 24-2014 is hereby further amended by inserting two additional and new provisions between Sections 3 and 4, which shall be read as follows:

**"Section 4. Special Beneficiaries.** The beneficiaries of the Free Movie Privilege may be extended to different classes or groups of individuals who are bona fide residents of the City of Bacoor in celebration or commemoration of any national or local events, subject to availability of funds, as may be determined and approved by the Parties. The Special Beneficiaries, excluding Senior Citizens and Persons with Disabilities, are entitled to the benefits of this privilege only once (1) per year upon presentation of their respective Special Bacoor Residents (SBR) Card, or in the absence thereof, any other valid government-issued identification card. The City Mayor has the sole authority to identify these Special Beneficiaries. Every Special Beneficiary is entitled to the privilege of this Ordinance on the following dates only:

a. During the Bacoor Cityhood Anniversary which is celebrated every June 23 of each year;

b. During the Bakood Festival which is celebrated every September 29 of each year;

c. During the Birthday celebration of the City Mayor of the City of Bacoor; and

d. Every 29<sup>th</sup> day of July beginning in 2024 to commemorate the merger of the various barangays of the City of Bacoor which was ratified in a plebiscite held on July 29, 2023.

Section 5. Waiver of Amusement Tax. The City Government of Bacoor shall exempt cinemas that will implement this ordinance from paying amusement taxes."

**Section 4.** Due to the insertion of the two additional provisions in City Ordinance No. 24-2014 mentioned above, Sections 4, 5, 6, 7, 8, 9 and 10 of the said Ordinance shall be re-numbered and shall be referred to henceforth as Sections 6, 7, 8, 9, 10, 11, and 12, respectively.

**Section 5.** The Sangguniang Panlungsod Secretariat is directed to print, within ten (10) working days from the date of effectivity of this legislation, a copy of City Ordinance No. 24-2014 as amended after incorporating therein all the revisions made by the Sangguniang Panlungsod to the said ordinance and to post the same in the official website of the city council as the "Libreng Sine Ordinance of Bacoor". A copy of the Libreng Sine Ordinance (City Ordinance No. 24-2014 as amended) shall be attached hereto and shall be deemed an integral part of this Ordinance.

**Section 6.** All ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**Section 7.** This Ordinance shall take effect immediately after its posting on the bulletin boards at the Bacoor City Hall, the Bacoor Public Market, and the Bacoor Hall of Justice.



**WHEREAS**, the Sangguniang Panlungsod passed City Ordinance No. CO 24-2014 (also known as "**An Ordinance Granting a Free Movie Privilege to all Bacoor Senior and Disabled Citizens 2014**"), a social service legislation intended for the benefit of senior citizens (SC) and persons with disabilities (PWD), on 4 September 2014;

**WHEREAS**, Section 2 of the said Ordinance provides that:

**"Section 2. Scope.** - This Ordinance shall only apply to cinemas operating within the territorial jurisdiction of the City of Bacoor, Cavite and may only be availed of every **Monday, Tuesday, Thursday, and Sunday** by senior citizens duly registered with the Office of the Senior Citizen's Affairs Office (OSCA) and Persons with Disabilities (PWD) who are permanent residents of the City of Bacoor, Cavite upon presentation of an identification card signed and issued by the City Mayor. (Emphasis supplied.)xxx".

**WHEREAS**, due to budgetary constraints, the implementation of the said Ordinance was suspended by the Office of the City Mayor beginning on 1 June 2019 pursuant to Memorandum Order No. 16, Series of 2019, dated 31 May 2019.

**WHEREAS**, on 18 September 2019, the City Mayor, Hon. Lani Mercado-Revilla, formally requested the Sangguniang Panlungsod to pass an ordinance amending Section 2 and 3 of City Ordinance No. CO 24-2014.

**NOW, THEREFORE**, be it ordained by the Sangguniang Panlungsod THAT:

**Section 1.** Section 2 of City Ordinance No. CO 24-2014 is hereby amended and shall henceforth read as follows:

**"Section 2. Scope.** - This Ordinance shall only apply in cinemas within SM City Bacoor and SM Molino and may only be availed of once a day every **Monday** by senior citizens **permanently residing in the City of Bacoor, Cavite who are duly registered with the Office of Senior Citizen's Affairs (OSCA), who have presented a**

Senior Citizens and PWDs who fail to present a valid senior citizen ID or PWD ID issued by the City Government of Bacoor upon request of representatives or employees of the cinema falling within the scope of this Ordinance may not avail of the privileges granted hereunder.**

**Section 2.** Section 3 of City Ordinance No. CO 24-2014 is hereby amended and shall henceforth read as follows:

**"Section 3. Free Cinema Admission.** All senior citizens and persons with disability within the scope provided under Section 2 hereof may be entitled free cinema admission once a day **every Monday to be** subsidized by the City Government of Bacoor, Cavite."

**Section 3.** Any provision of this Ordinance found void, invalid or unconstitutional by a court of competent jurisdiction shall not affect the rest of this Ordinance not affected by the said judicial finding of nullity, invalidity or unconstitutionality.

**Section 4.** This Ordinance shall take effect immediately after it has been published in a newspaper of general circulation in the Province of Cavite and after it has been approved by the Sangguniang Panlalawigan of the Province of Cavite.

**NOW THEREFORE**, during regular session assembled, upon motion of Councilor Bayani M. De Leon, unanimously seconded by all the Councilors present, **BE IT ORDAINED, AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod to consolidate and introduce amendments to aforesaid Ordinances to read as follows:

**Section 1. Title.** - This Ordinance shall be known as "**An Ordinance Granting a Free Movie Privilege to all Bacoor Senior and Disabled Citizens 2014**".

**Section 2. Scope.**- This Ordinance shall only apply to cinemas operating within the territorial jurisdiction of the City of Bacoor, Cavite and may only be availed of every Monday, Tuesday, Thursday, and Sunday by senior citizens duly registered with the Office of the Senior Citizen's Affairs Office (OSCA) and Persons with Disabilities (PWD) who are permanent residents of the City of Bacoor, Cavite upon presentation of an identification card signed and issued by the City Mayor.

**Section 3. Free Cinema Admission.** All senior citizens and persons with disability within the scope provided under Section 2 hereof may be entitled free cinema admission once a day every Monday, Tuesday, Thursday and Sunday subsidized by the City Government of Bacoor, Cavite.

**Section 4. Appropriations.** All existing appropriations for the purposes of enabling Ordinance No. 2013-020 also known as the "Bacoor Senior Citizen Cinema Discount Ordinance 2013" and City Ordinance No. 2013-021 also known as the "2013 Free Cinema Admission Ordinance for the Disabled Citizens of Bacoor" shall remain in force until its full exhaustion. Should there be a need to augment such existing appropriations, the Sanggunian shall, subject to availability of funds, enact a supplemental appropriations in support thereof.

**Section 5. Implementing Rules and Guidelines.** To ensure the successful implementation of this Ordinance, the City Mayor is hereby authorized to draw up the necessary Implementing Rules and Guidelines for the manner of payment to all cinema owners/administration and the availment procedures of senior citizens and PWDs under this Ordinance.

**Section 6. Authority to enter into a Memorandum of Agreement.** The City Mayor is hereby empowered to enter into a Memorandum of Agreement with cinema owners/administration within the City of Bacoor for the effective implementation of this Ordinance.

**Section 7. Reservation Clause.** The City Mayor reserves the right:

- a) to suspend the grant of privileges under this Ordinance anytime whenever the fundings therefor have already been exhausted and there is no clear funding source for its continued implementation;
- b) to terminate any existing agreement in relation to this Ordinance should there be a *prima facie* of fraud, concealment or any other unlawful acts committed by cinema owners/administration, without prejudice to the availment of applicable administrative, civil and/or criminal remedies; and
- c) not to enter into Memorandum of Agreement with any cinema owner/administration for justifiable or reasonable causes. *Provided*, such cause shall be communicated to the *Sangguniang Panlungsod* immediately with the exercise of such reservation.

**Section 8. Separability Clause** - Any provision of this Ordinance found void, invalid or unconstitutional by a court of competent jurisdiction shall not affect the rest of this Ordinance not affected by the said judicial finding of nullity, invalidity or unconstitutionality.

**Section 9. Repealing Clause** - This ordinance expressly repeals City Ordinance No. 2013-020 also known as the "Bacoor Senior Citizen Cinema Discount Ordinance 2013" and the City Ordinance No. 2013-021 also known as the "2013 Free Cinema Admission Ordinance for the Disabled Citizens of Bacoor", and all of their precedent ordinances pertaining to the same subject matter.

**Section 10. Effectivity.** - This Ordinance shall take effect immediately after it has been posted in at least three (3) conspicuous places within the City of Bacoor, Cavite.
