Series of 2026

AN ORDINANCE AUTHORIZING THE GRANT OF SCHOLARSHIPS AND CASH INCENTIVES TO VARIOUS STUDENTS RESIDING IN THE CITY OF BACOOR, CAVITE WHO ATTAINED EXEMPLARY EDUCATIONAL HONORS, WHO HAVE BROUGHT PRESTIGE TO THE CITY AND TO THE PHILIPPINES IN NATIONAL OR INTERNATIONAL COMPETITIONS, OR WHO TOPPED PROFESSIONAL LICENSURE OR BAR EXAMINATIONS.

WHEREAS, the State is constitutionally mandated to promote public education and to encourage the youth to actively aspire for excellence for the betterment of the country.

WHEREAS, Section 6 of Republic Act No. 10648 (also known as the "Iskolar ng Bayan Act of 2014") encouraged local government units to create their own scholarship programs.

WHEREAS, Section 11 (5) (xi) of Republic Act No. 10160 (the "Charter of the City of Bacoor") empowered the Sangguniang Panlungsod to establish a scholarship fund for the poor but deserving students in schools located within its jurisdiction or for students residing within the City.

WHEREAS, Section 11 (2) of RA 10160 empowered the Sangguniang Panlungsod to enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes and granting tax exemptions, incentives or reliefs.

NOW THEREFORE, be it ordained by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite that:

Section 1. Title. This Ordinance shall be known and referred to as the "**Bacoor Scholarship and Excellence Incentives Ordinance**".

Section 2. Creation of the Iskolar ng Bacoor Program.
A scholarship program for the benefit of all high school and college students residing in the City of Bacoor, Cavite enrolled in any reputable educational institution in the Philippines to be known as the **Iskolar ng Bacoor Program** (the "Program") is hereby created. All qualified beneficiaries of the Program shall be given **P3,000.00 and above** per year to be taken from the available funds of the City Government and shall be awarded on any date chosen by the City Mayor based on the official schedule of activities of the City Government in relation to the celebration of the founding of the City of Bacoor.

Section 3. Creation of the Bacoor Excellence Incentive Program. An incentives program that will recognize the academic, sports, cultural, literary, and artistic achievements of all bonafide residents of the City of Bacoor to be known as the **Bacoor Excellence Incentive Program** (the "BEI Program") is hereby created. The said achievements shall include winning in national or international competitions, acquiring Latin honors upon graduation, or entering the Top Ten of all professional licensure or bar examinations. Under the BEI Program, all qualified beneficiaries who made the following achievements shall receive the following cash incentives to be taken from available funds of the City Government:

International Competitions	Gold – PhP20,000.00 and above
	Silver – PhP15,000.00 and above
	Bronze – PhP10,000.00 and above
	Finalist - PhP5,000 and above
	National Level

Provided that: the City Mayor shall determine the exact amount to be granted to qualified beneficiaries based on the availability of funds.

Section 4. Duplication of Incentives. Beneficiaries who won multiple achievements and are qualified to receive more than one type of incentive shall not be precluded from receiving the same.

Section 5. Implementing Rules and Regulations. The City Administrator, being the primary implementor of this Ordinance, is hereby given 60 working days from the effectivity date hereof within which to submit the Implementing Rules and Regulations of this Ordinance for the review and approval of the City Mayor.

Section 6. Repeal. All ordinances, resolutions, orders and other local issuances that are inconsistent with the provisions of this ordinance are hereby repealed and/or modified accordingly.
