AN ORDINANCE ADOPTING AND INSTITUTIONALIZING THE IMPLEMENTATION OF THE SUSTAINABLE LIVELIHOOD PROGRAM (SLP) OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) IN THE CITY OF BACOOR, CAVITE.

WHEREAS, pursuant to Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied, and those essential for efficient and effective governance, including those necessary for the promotion of the general welfare;

WHEREAS, the City of Bacoor, Cavite recognizes the importance of adopting and institutionalizing the Sustainable Livelihood Program (SLP) of the Department of Social Welfare and Development (DSWD) to address poverty reduction, enhance economic prosperity, and empower communities;

NOW, THEREFORE, be it ordained by the 6th Sangguniang Panlungsod of the City of Bacoor, Cavite, in regular session assembled, that:

SECTION 1. TITLE. - This Ordinance shall be known as "**An Ordinance Adopting and Institutionalizing the Implementation of the Sustainable Livelihood Program (SLP)**"

SECTION 2. SCOPE AND COVERAGE. – This ordinance mandates the adoption and institutionalization of the implementation of the Sustainable Livelihood Program (SLP) of the Department of Social Welfare and Development (DSWD) in the City of Bacoor, Cavite.

SECTION 3. DEFINITION OF TERMS. – The terms defined in the DSWD Memorandum Circular No. 07, Series of 2023, shall apply to this Ordinance.

SECTION 4. IMPLEMENTING MECHANISM. – The City Government of Bacoor, through the City Social Welfare and Development Office (CSWDO), shall adhere to and actively implement the Sustainable Livelihood Program as one of its major programs.

SECTION 5. IMPLEMENTING ARRANGEMENTS AND OPERATIONAL STRUCTURES – The Department of Social Welfare and Development Region IV-A (CALABARZON) shall provide Technical Assistance and Resource Augmentation (TARA) whenever the need arises. The City Government of Bacoor shall allocate funds from its General Fund in addition to other sources to support the implementation of the program.

SECTION 6. APPROPRIATION. – The City Government of Bacoor shall appropriate funds from its Annual or Supplemental Budget for the successful implementation of the Sustainable Livelihood Program.

SECTION 7. REPEALING CLAUSE. – All ordinances, rules, and regulations inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 8. SEPARABILITY CLAUSE. – if any provision of this Ordinance is declared invalid, the other provisions not affected thereby shall remain in full force and effect.

SECTION 9. EFFECTIVITY CLAUSE. – This Ordinance shall take effect after fifteen (15) days following its publication in a newspaper of general circulation or posting in at least three (3) conspicuous places within the City of Bacoor.
