CITY ORDINANCE NO. 516-2026

AN ORDINANCE CREATING VARIOUS POSITIONS IN THE PLANTILLA OF THE OFFICE OF THE ACCOUNTING AND INTERNAL AUDIT SERVICES OF THE CITY GOVERNMENT OF BACOOR TO TAKE EFFECT ON FISCAL YEAR 2026 PURSUANT TO RELEVANT CIVIL SERVICE REGULATIONS.

WHEREAS, on 20 April 2026, the Office of the City Mayor formally requested the Sangguniang Panlungsod to create two (2) positions in the plantilla of the Office of the Accounting and Internal Audit Services of the City Government of Bacoor to take effect on Fiscal Year 2026 pursuant to relevant civil service regulations.

WHEREAS, the creation of additional permanent positions in the Office of the Accounting and Internal Audit Services of the City Government of Bacoor will improve the quality of service being rendered by the said department to the public as it will alleviate and hasten the reporting and recording process of various City Government transactions and will ensure continuity, accountability, and institutional strength in the delivery of mandated services by the aforementioned office.

WHEREAS, Section 11, (viii) of Republic Act No. 10160 (the "Charter of the City of Bacoor") empowered the Sangguniang Panlungsod to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects and services and activities of the city government.

NOW THEREFORE, upon the motion of Councilor Miguel N. Bautista, be it ordained by the 6th Sangguniang Panlungsod that:

Section 1. Creation of Plantilla Positions under the Office of the Accounting and Internal Audit Services. The following

Section 3. Compensation and Benefits. The salaries, allowances, and other emoluments of the positions herein created shall be in accordance with the Salary Standardization Law and other applicable issuances, and shall be subject to all existing budgeting, accounting, civil service, and auditing laws, rules, and regulations.

Section 4. Appropriation. The amount necessary for the implementation of this Ordinance shall be charged against the Supplemental Appropriations for CY 2026 subject to the usual accounting and auditing requirements.

Section 5. Repeal. All ordinances, executive orders, or memoranda inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 6. Separability. In case the Civil Service Commission (CSC) or a court of law of competent jurisdiction declares any provision of this Ordinance void or unconstitutional, the remaining provisions hereof not affected by the said declaration shall remain valid and enforceable.

Section 7. Effectivity. This Ordinance shall become effective immediately after it has been posted in at least three (3) conspicuous places within the City of Bacoor.
