**CITY ORDINANCE NO. 517-2026**  
**Series of 2026**

**AN ORDINANCE CREATING VARIOUS POSITIONS IN THE PLANTILLA OF THE CITY LIVELIHOOD AND DEVELOPMENT DEPARTMENT OF THE CITY GOVERNMENT OF BACOOR TO TAKE EFFECT ON FISCAL YEAR 2026 PURSUANT TO RELEVANT CIVIL SERVICE REGULATIONS.**

**WHEREAS**, on 28 April 2026, the Office of the City Mayor sent a formal request to the Sangguniang Panlungsod for the creation of **thirteen (13) permanent positions** in the plantilla of the City Livelihood and Development Department of the City Government of Bacoor to take effect on Fiscal Year 2026 pursuant to relevant civil service regulations.

**WHEREAS**, the creation of additional permanent positions at the City Livelihood and Development Department will result in greater productivity for the said office in terms of the number of beneficiaries that it can serve and the number of projects and programs it can undertake for the benefit of the general public.

**WHEREAS**, Section 11, (viii) of Republic Act No. 10160 (the "Charter of the City of Bacoor") empowered the Sangguniang Panlungsod to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects and services and activities of the city government.

**NOW THEREFORE**, upon the motion of Councilor Miguel N. Bautista, be it ordained by the 6<sup>th</sup> Sangguniang Panlungsod that:

**Section 1. Creation of Plantilla Positions under the City Livelihood and Development Department.** The following plantilla positions under the City Livelihood and Development Department whose appointment, salaries, and benefits shall be subject to pertinent civil service regulations are hereby created:

**Section 3. Compensation and Benefits.** The salaries, allowances, and other emoluments of the positions herein created shall be in accordance with the Salary Standardization Law and other applicable issuances, and shall be subject to all existing budgeting, accounting, civil service and auditing laws, rules, and regulations.

**Section 4. Appropriation.** The amount necessary for the implementation of this Ordinance shall be charged against the Supplemental Appropriations for CY 2026 subject to the usual accounting and auditing requirements.

**Section 5. Repeal.** All ordinances, executive orders, or memoranda inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

**Section 6. Separability.** In case the Civil Service Commission (CSC) or a court of law of competent jurisdiction declares any provision of this Ordinance void or unconstitutional, the remaining provisions hereof not affected by the said declaration shall remain valid and enforceable.

**Section 7. Effectivity.** This Ordinance shall become effective immediately after it has been posted in at least three (3) conspicuous places within the City of Bacoor.
