A RESOLUTION AUTHORIZING THE HON. CITY MAYOR, STRIKE B. REVILLA, TO SIGN AND ENTER INTO MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE DEPARTMENT OF EDUCATION (DepEd) AND THE NATIONAL WATER RESOURCES BOARD (NWRB) REGARDING THE DEVELOPMENT OF A "GROUNDWATER MANAGEMENT PLAN (GMP) FOR HIGHLY URBANIZED WATER CONSTRAINT CITIES IN METRO MANILA AND CAVITE."

WHEREAS, the National Water Resources Board (NWRB) under Article 3(d) of the Water Code of the Philippines (PD1067), has been granted powers to regulate the exploitation, development, conversation, and protection of the country's water resources.

WHEREAS, the NWRB undertakes the project "Development of Groundwater Management Plan for Highly Urbanized Water Constraints Cities in Metro Manila and Cavite", with the objective of developing a groundwater management plan for Metro Manila and Cavite that considers future impact of climate change and provide framework and decision support tools using science-based methodology, to effectively manage groundwater resources.

WHEREAS, the NRWB requested the Local Government of Bacoor and the DepEd of Bacoor to allow NRWB the use of a portion of a lot in the identified selected campus in the city of Bacoor namely, Queens Row Elementary School and Bacoor Elementary School for the construction of **three(3)** groundwater monitoring wells.
