A RESOLUTION REVOKING THE AUTHORITY GRANTED TO FORMER MAYOR STRIKE B. REVILLA TO INITIATE THE FILING OF EXPROPRIATION PROCEEDINGS FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR FOR THE PURCHASE OF A 5,000-SQUARE METER PORTION OF THE 7,681-SQUARE METER LOT COVERED BY TCT NO. T-978556 REGISTERED UNDER THE NAME OF MPZ VENTURES INC. SUPPOSEDLY TO BE USED FOR THE PROPOSED INTEGRATED TRANSPORT TERMINAL PROJECT OF THE CITY DUE TO LACK OF FUNDS TO PUSH THROUGH WITH THE SAID PROJECT.

WHEREAS, on 22 February 2016, the Sangguniang Panlungsod passed City Ordinance No. CO-10-2016 authorizing the former Mayor of the City of Bacoor and now the Representative of the 2nd District of the Province of Cavite to the House of Representatives, Hon. Strike B. Revilla, to initiate the filing of expropriation proceedings for and on behalf of the city government for the expropriation of a 5,000-square meter portion of a 7,681-square meter lot covered by TCT No. T-978556 registered under the name of MPZ Ventures Inc. supposedly to be used for the proposed construction of an Integrated Transportation Terminal for the City of Bacoor.

WHEREAS, the representatives of the registered owner of the property covered by the said ordinance requested the Sanggunian to revoke the afore-mentioned authority so that it can be sold to a third party and be developed for various commercial uses later on.

WHEREAS, the Sangguniang Panlungsod took note that the city government did not appropriate funds for the construction of the said Integrated Transportation Terminal or for the expropriation of the said real property.

NOW THEREFORE, upon motion of Hon. Edwin G. Gawaran, unanimously seconded by all the members of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to revoke the authority granted to former Mayor of the City of Bacoor and now the Representative of the 2nd District of the Province of Cavite to the House of Representatives, Hon. Strike B. Revilla, under City Ordinance No. CO-10-2016 to initiate the filing of expropriation proceedings for and on behalf of the city government for the expropriation of a 5,000-square meter
