A RESOLUTION APPROVING THE PROPOSED SEAL OF THE RESOURCES EDUCATION VOCATIONAL INSTRUCTION LIVELIHOOD LEARNING ACADEMIC (R.E.V.I.L.L.A.) CENTER OF THE CITY OF BACOOR, CAVITE AND AUTHORIZING ITS USE FOR VARIOUS OFFICIAL FUNCTIONS INCLUDING FOR PURPOSES OF ACCREDITATION WITH THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA).

WHEREAS, on 15 July 2020, the Office of the City Legal Service submitted a design for the proposed seal of the Resources Education Vocational Instruction Livelihood Learning Academic (R.E.V.I.L.L.A.) Center of the local government of the City of Bacoor, Cavite for the consideration of the Sangguniang Panlungsod.


WHEREAS, the proposed seal design consists of a circle divided into three parts resembling an escutcheon: the upper part of the design contains a miniaturized replica of the official seal of the city government to symbolize that the said facility represents the local government of the City of Bacoor, Cavite; the lower left hand portion of the escutcheon consists of an artistic rendering of a gear and a leaf to symbolize labor and livelihood; the lower right hand of the escutcheon contains the official seal of the Technical Education and Skills Development Authority (TESDA) to symbolize the adherence of the Center to the programs and ideals of the said government agency.


WHEREAS, a committee hearing was conducted regarding the said proposed seal design and the Joint Committee that reviewed the said proposal recommended its approval.
