A RESOLUTION RESPECTFULLY REQUESTING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO ORDER THE SUSPENSION OF THE TEMPORARY BUSINESS PERMIT ISSUED BY THE BUSINESS PERMITS AND LICENSING OFFICE (BPLO) TO EMILY M. BANAAG (REGIE & REGINE RIDES GAMES & AMUSEMENT CENTER) FOR THE OPERATION OF A BINGO, FUN GAMES, AND RIDES AT QUEEN'S ROW CENTRAL CIRCLE AREA DUE TO ALLEGED ACTS OF GRAFT AND CORRUPTION RELATED TO ITS ISSUANCE.

**WHEREAS**, on 22 September 2022, the Sangguniang Panlungsod received a letter from Ms. Maricar A. Dionisio, President/Chairperson of Queen's Row Subdivision Inc. requesting the city council to conduct an investigation against the Punong Barangay of Queen's Row Central over the issuance of a barangay permit "for the operation of a recreational activity in Block 31 of Brgy. Queen's Row Central, Queen's Row Subdivision, Bacoor City, Cavite without requiring from the operator any consent or approval from QRSI". A copy of the said complaint is attached hereto as **Annex "A"**.

**WHEREAS**, the said complaint was referred to the Committee on Ethics and Government Reorganization which conducted a hearing thereon on 29 September 2022.

**WHEREAS**, during the said hearing both Emily Banaag owner of Regie and Regine Rides Games and Amusement Center and Punong Barangay Fe M. Ang admitted that they agreed that a monetary consideration in the amount of Php. 100,000.00 in exchange for the issuance of a barangay permit by Ang — an act which if proven to be true in a court of law is

**WHEREAS**, upon further inquiry, it was learned by the Committee that Punong Barangay Fe M. Ang issued the said permit on 19 September 2022. A copy of the said Barangay Permit is attached hereto as **Annex "B"**.

**WHEREAS**, the Committee also learned that, by virtue of the Barangay Permit mentioned above, a Temporary Business Permit was issued in favor of Ms. Banaag and "Regie & Regine Rides Games & Amusement Center" on 20 September 2022. A copy of the said Temporary Business Permit is attached hereto as **Annex "C"**.

**WHEREAS**, members of the Sangguniang Barangay of Queens Row Central sent a letter to the BPLO requesting for the revocation of the Temporary Business Permit issued by the said office to Ms. Banaag.

**WHEREAS**, the Committee decided to conduct more hearings on the said matter to determine if irregularities attended the issuance of the Temporary Business Permit mentioned above. In the meantime, the Committee recommends that the said Temporary Business Permit should be suspended and the operation of the said business/amusement center should be put on hold while the Committee is conducting its investigation on the said complaint.

**NOW THEREFORE**, upon motion of Hon. Reynaldo D. Palabrica, unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, Cavite to respectfully request the City Mayor, Hon. Strike B. Revilla, to suspend the Temporary Business Permit issued in favor of Ms. Emily Banaag and "Regie & Regine Rides Games & Amusement Center" on 20 September 2022 pending the completion of the investigation of the Committee on Ethics and Government Reorganization.

**RESOLVED LASTLY**, to furnish the Office of the City Mayor, Ms. Emily M. Banaag, the BPLO, the Office of the City Administrator, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and all government agencies concerned with copies of this Resolution.
