there is not enough time for the Bids and Awards Committee of the city government to conduct advanced procurement proceedings before the end of CY 2022 and will only be able to conduct biddings for the said contracts by January 2023.

**WHEREAS**, if the said services are not awarded to contractors that will win in the said bidding process before the end of 2022, the ability of the city government to deliver various public services shall be adversely affected and it is possible that a public health crisis might ensue if garbage generated by city residents during the holidays are not collected promptly.

**WHEREAS**, Section 16 of Republic Act No. 7160 gives local governments the power to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

**WHEREAS**, the contracts of the companies mentioned above must be extended until January 31, 2023 to ensure that the ability of the city government to deliver high quality public service shall not be adversely affected and to prevent the occurrence of a public health and sanitation crisis if garbage generated by city residents during the holidays are not collected promptly.

**NOW THEREFORE**, upon motion of Hon. Rogelio Nolasco, unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5<sup>th</sup> Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the extension of the contracts of **AQUARIUS SECURITY AGENCY, TOPSERVE SERVICE SOLUTIONS INC., and INTERNATIONAL SOLID WASTE INTEGRATED MANAGEMENT SPECIALIST INC.** with the local government of the City of Bacoor, Cavite until January 31, 2023.

**RESOLVED LASTLY**, to furnish Aquarius Security Agency, Topserve Service Solutions Inc., International Solid Waste Integrated Management Specialist Inc., the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this Resolution.
