WHEREAS, the DTI created OTOP.PH (also known as the OTOP Philippines Hub) in various regions or provinces as a market access platform for One Town, One Product (OTOP) as the marketing component of the program;

WHEREAS, the Bacoor Livelihood Producers Cooperative is a domestic entity that aims to provide an OTOP Hub to DTI for its locally made products by making them readily made available to the residents of the City of Bacoor;

WHEREAS, the City Government of Bacoor fully support the implementation and establishment of an OTOP Philippines Hub or OTOP.PH in the city;

WHEREAS, on 14 December 2022, the Office of the City Mayor submitted the draft Tripartite Memorandum of Agreement to be entered among the City Government of Bacoor, Department of Trade and Industry Region IVA, and Bacoor Livelihood Producers Cooperative to the Sangguniang Panlungsod for its review and consideration.
