WHEREAS, on 19 June 2023, the Office of the City Mayor endorsed a letter to the Sangguniang Panlungsod requesting for a resolution authorizing the purchase of five (5) motor vehicles by the General Services Office for the use of different city government offices pursuant to the Peace and Order/Public Safety (POPS) Program of the City of Bacoor, Cavite.

WHEREAS, in compliance with Memorandum Circular No. 2022-105, dated August 25, 2022 issued by the Department of the Interior and Local Government (DILG), entitled: "The Revised Policy Guidelines on Motor Vehicles Purchase/Acquisition, Use and Rental by the Local Government Units", the General Services Office requested the Sangguniang Panlungsod to authorize the purchase of five (5) units of motor vehicle for the use of different offices by way of a resolution as described below:

RESOLVED FURTHER, to authorize the City Mayor to sign all agreements or documents related to the said purchase that complies with the foregoing conditions.

RESOLVED LASTLY, to furnish the DILG, the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and other government agencies concerned with copies of this Resolution.
