**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE CAVITE STATE UNIVERSITY (CavSU) REGARDING THE CLINICAL AFFILIATION OF CavSU MIDWIFERY AND NURSING STUDENTS TO BE ASSIGNED TO BARANGAY HEALTH CENTERS AND TO THE CITY OF BACOR BIRTHING HOME.**

**WHEREAS**, the Office of the City Mayor, formally requested the Sangguniang Panlungsod through a letter dated August 21, 2024 to pass a resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement (MOA) on behalf of the City Government of Bacoor with the Cavite State University.

# MEMORANDUM OF AGREEMENT.

## KNOW ALL MEN BY THESE PRESENT:

This Memorandum of Understanding made and entered into and executed by and between:

The **CITY OF BACOR**, with office address at City of Bacoor, Cavite and herein represented by **HON. STRIKE B. REVILLA**. its City Mayor hereinafter known as the **FIRST PARTY**;

and

The **CITY HEALTH OFFICE OF BACOR** a public corporation duly organized and existing under Philippine laws, represented herein by **DR. IVY MARIE YRASTORZA** City Health Officer, of legal age, Filipino citizen, married and with office address at the City of Bacoor, Province of Cavite, hereinafter referred to as the **SECOND PARTY**;

and

The **CAVITE STATE UNIVERSITY**, a public higher education institution duly created and existing under RA 8468 with office address at Brgy. Bancod, Indang Cavite, represents herein by its President, **DR. HERNANDO D. ROBLES**, hereinafter referred to as the **THIRD PARTY**;

## WITNESSETH:

WHEREAS, the students of the THIRD PARTY taking up **BACHELOR OF SCIENCE IN MIDWIFERY(BSM)** and **BACHELOR OF SCIENCE IN NURSING(BSN)** have to undergo affiliation and training in Department of Health (DOH) administered hospitals and other government facilities to ensure the production and development of Health Human Resources towards the promotion, maintenance and delivery of health services;

WHEREAS, the FIRST PARTY through its City Health Office allows the use of its City Health Unit and related facilities as community health resources for the learning and training of the students of the THIRD PARTY;


WHEREAS, to maintain a harmonious relationship among all parties concerned, the terms of affiliation and training of students shall be governed by Provincial Resolution No. 157, series of 2008.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties agrees to the following:

## DUTIES AND RESPONSIBILITIES:

### A. CITY OF BACOR

1. Oversee and support activities of student's affiliation program and training activities at the CHU and community settings.
2. Facilitate available equipment, materials and the needed paraphernalia for community health related activities of the students.
3. Maintain safety and security of the students during the clinical exposure in the CHU and Community Health Nursing activities.

4. Be Responsible and liable to the fullest extent for any violation of the provisions of Provincial Resolution No. 157 series of 2008.

#### B. CITY HEALTH OFFICE OF BACCOOR

1. Enforce rules and regulations regarding admission, supervision and training of students as prescribed by the institution thru the respective department heads.
2. Allow the students of the THIRD PARTY to utilize the following non-Covid clinical areas including Lying-In , OB Ward, DR, NICU, ER-OPD and City Health Units(CHU) and Barangay Health Stations(BHS) as the need for utilization arises for their clinical practicum course.
3. Allow students of the THIRD PARTY to complete of the number of hours for Related Learning Experience (RLE) per level as required for course completion of the Commission on Higher Education (CHED).
4. Permit the attendance/ participation of the students to clinical conferences, symposiums or specified activities and health programs of the RHU.
5. Allow the use of available rooms or spaces designated for training purposes.
6. Supervise and monitor activities of students" affiliation and training activities at the RHU and community at all levels in accordance with the institution policies.

#### C. CAVITE STATE UNIVERSITY

- Submit the certified list of qualified students who are to undergo affiliation as scheduled per RLE rotation plan and in groups following the CHED's guidelines of student-faculty ratio.
- Observe all the rules and regulation set forth by the FIRST and SECOND PARTY as pertains to student's affiliation.
- Provide a Clinical Instructor in each group in every area who will be directly responsible for the students while undergoing clinical practicum in the SECOND PARTY facility.
- Provide necessary supplies and materials of students for effective nursing care and student's learning experiences.
- Be responsible for the care of students in case of illness or injury during the course of affiliation.
- Facilitate the reimbursement of in cash or in kind of all losses (such as break-ages of equipment) as a result of carelessness or gross negligence of the student.
- Pay THREE HUNDRED AND FIFTY PESOS ( PhP 350.00) for 80-96 hours per student and 4/hr for make-up duties as affiliation fee and THREE HUNDRED (PhP 300.00) per student as utilization fee per semester to the FIRST and SECOND PARTIES.

That the term of this MOA shall be effective from September 2024 to June 2026.
