A RESOLUTION CREATING A TASK FORCE THAT WILL STUDY THE FEASIBILITY OF ESTABLISHING A PUBLIC SCHOOL BUS SYSTEM IN THE CITY OF BACOR, CAVITE TO IMPROVE THE FLOW OF TRAFFIC ON PUBLIC ROADS NEAR VARIOUS SCHOOLS, PROMOTE PUBLIC SAFETY, AND TO PROVIDE AN ADDITIONAL SOURCE OF REVENUE FOR THE BACOR TRAFFIC MANAGEMENT DEPARTMENT (BTMD) TO BE USED TO AUGMENT THE SALARIES OF TRAFFIC AIDES.

WHEREAS, every local government was empowered by Section 16 of Republic Act No. 7160 (the "Local Government Code of 1991") to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

WHEREAS, Section 458, paragraph (5), subparagraph (v) of the Local Government Code of 1991 gave the Sangguniang Panlungsod the power to, among others, regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same; establish bus and vehicle stops and terminals or regulate the use of the same by privately-owned vehicles which serve the public.

WHEREAS, a report submitted by the Bacoor Traffic Management Department (BTMD) revealed that roads adjacent to various schools within the City of Bacoor become traffic gridlocks during rush hour due to the influx of privately owned motor vehicles and public utility tricycles being used to drop off or pick-up students.

WHEREAS, it was proposed by the Committee on Public Transportation and Management for the Sangguniang Panlungsod to create a task force that study the feasibility of establishing a public school bus system in the City of Bacoor to improve the flow of traffic on public roads within the City that are near schools, promote public safety, and provide an additional source of revenue that may be utilized by the BTMD to augment the salaries of its personnel which may include traffic aides.
