That, the DONOR affirms that the donation is not made with intent to deceive its creditors and that it has reserved for itself and its legal obligations sufficient funds and properties;

That, the DONEES are obliged to maintain the abovementioned Donated Properties in good condition and shall use them exclusively for governmental purposes for the effective delivery of public service;

That, the DONEES shall use the Donated Properties exclusively for public use, and the DONOR has the authority to revoke this Deed should the Donated Properties be utilized privately;

That each DONEE hereby accepts and receives this donation made in its favor by the DONOR and hereby expresses its appreciation and gratefulness for the kindness and generosity of the DONOR in recognizing the abovementioned goods.

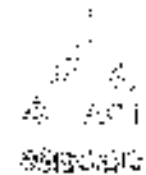
