

Dennis Madrigal, OIC, Regional Director, REGION IVA, Bureau of Treasury, formally informed the City Mayor that Thirteen Million Nine Hundred Eighty Thousand Pesos (PhP13,980,000.00) has been granted and credited to the account of the city government through a Notice of Authority to Debit Account Issued (NADAI).


