**WHEREAS**, on 12 February 2025, the Sangguniang Panlungsod received an endorsement letter from the Philippine National Police Regional Office 4A requesting for the adoption of the Localized Anti-Criminality Action Plan (LACAP) entitled: "Clear Face Policy", requiring individuals to remove items that could conceal their identity (e.g. helmets, hats, facemask, sun glasses). The said plan aims to reduce the risk of robbery and theft in convenience stores, financial institutions and other business establishments operating within the City of Bacoor.

**WHEREAS**, the abovementioned subject was deliberated upon by the city council where it was found that the proposed security plan will enhance the safety and well-being of the public and safeguard both business and residents from harm. The said proposed plan is incorporated hereto and will be made a part of this Resolution as **Annex "A"**.

### Bacoor CPS Localized Anti-Criminality Action Plan (LACAP) "Clear Face Policy"

#### References:

#### Purpose

This measure is to enhance security and reduce the risk of robbery and theft in convenience stores, financial institution, and other business establishment. By requiring individuals to remove items that could conceal their identity, such as bonnets, helmets, hats, and facemasks, the initiative aims to deter criminal activity, making it harder for would-be criminals to disguise themselves.

#### Situation

During the period of CY 2023-2024, the Bacoor PNP recorded 32 robbery incidents targeting business establishments within the city. These incidents sparked widespread concern, as many of the suspects utilized various forms of concealing paraphernalia—such as bonnets, helmets, caps, scarves, and facemasks—to hide their identities while committing the crimes. This pattern of behavior raised significant security alarms, prompting the Bacoor PNP to take swift, proactive measures. The goal is to disrupt criminal activities, enhance public safety, and safeguard both businesses and residents from further harm.

### Mission

The Bacoor PNP, in alignment with its mission and functions, together with the Bacoor LGU, will implement proactive measures to prevent the occurrence of robbery and theft within the city. By enforcing strategies such as requiring individuals to remove items that could conceal their identity—such as bonnets, helmets, hats, scarves, and

facemasks—before entering convenience stores and other business and financial establishments.

#### Definition of terms

- a. Cap/Hat- a covering of the head usually having a shaped of crown or brim.
- b. Helmets- a head gear of any kind and type which are used by motorcycle riders that covers the head/face of an individual;
- c. Scarf- a board band of cloth worn about the shoulders, around the neck and over the head where the nose and mouth are covered.
- d. Bonnet- a brimless cap of seamless wooden fabric or cloth or straw hat tied under the chin.
- e. Dark Shades/Glasses- an eye wear which conceals eye of a person.
- f. Business Establishment- any industrial or commercial organization or enterprise including but not limited to proprietorship, partnership, firm, business trust or joint venture.
- g. Face- the front part of a person's head from the forehead to the chin

#### Tasking

1. Bacoor Component City Police Station
  - a. OPR of the implementation of this action plan.
  - b. Coordinate with BPLD for the list of business and other financial establishment in the city.
  - c. Conduct Security Survey Inspection.
  - d. Conduct monitoring and to all establishments to ensure 100% compliance.
  - e. Conduct information dissemination to the owners/management of business and financial establishment regarding the Clear Face Policy
  - f. Post IEC Materials regarding the Clear Face Policy
  - g. Perform other task as directed.
2. BPLD
  - a. Provide updated list of list of business and other financial establishment in the city.
3. Sanguniang Panlungsod
  - a. Enact Ordinance and Resolution for this action plan

- a. Adherence to the rule of law;
- b. Lateral coordination is encouraged; and
- c. Perform other task as directed.
