A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT WITH THE CITY OF SAKURAGAWA, JAPAN FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR.

WHEREAS, on 11 December 2023, the Sangguniang Panlungsod passed City Resolution No. 2023-401 entitled: "A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE DEED OF DONATION WITH THE CITY OF SAKURAGAWA AND SAKURAGAWA CITY INTERNATIONAL FRIENDSHIP ASSOCIATION FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR REGARDING THE DONATION OF VARIOUS ITEMS SUCH AS BAGS, SCHOOL SUPPLIES AND MUSICAL INSTRUMENTS TO LESS FORTUNATE CHILDREN AND CHOSEN PUBLIC SCHOOLS IN THE CITY OF BACOR, CAVITE".
