A RESOLUTION ENDORSING THE PROPOSED PROJECTS AMOUNTING TO TWENTY-EIGHT MILLION ONE HUNDRED FORTY THOUSAND PESOS (PHP28,140,000.00) OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR THE AVAILMENT OF THE LOCAL GOVERNMENT SUPPORT FUND - FINANCIAL ASSISTANCE (LGSF-FA) TO LOCAL GOVERNMENT UNITS UNDER REPUBLIC ACT NO. 11975 (THE "GENERAL APPROPRIATIONS ACT FOR FISCAL YEAR 2024").

WHEREAS, the national government appropriated Fourteen Billion Thirty-Five Million Ninety Thousand Pesos (PhP14,035,090,000.00) for financial assistance to Local Government Units (LGUs) pursuant to Special Provision (SP) No. 1 of the Local Government Support Fund- Financial Assistance (LGSF-FA) under Republic Act No. 11975 or the "General Appropriations Act for Fiscal Year 2024".

WHEREAS, the Department of Budget and Management's Local Budget Circular No. 155 dated February 15, 2024 provides the guidelines on the release and utilization of the Local Government Support Fund-Financial Assistance to Local Government Units ("LGSF-FA to LGUs") under the General Appropriations Act for FY 2024.

WHEREAS, the amount of Twenty-Eight Million One Hundred Forty Thousand Pesos (PhP28,140,000.00) has been granted by the DBM which was credited to the account of the city government through a Notice of Authority to Debit Account Issued (NADAI).

WHEREAS, the following priority projects/programs/activities valued at Twenty-Eight Million One Hundred Forty Thousand Pesos (PhP28,140,000.00) were proposed by the city government to be funded under the LGSF-FA to wit:
