**A RESOLUTION RESPECTFULLY REQUESTING AND AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SUSPEND CLASSES IN ALL LEVELS WHENEVER THE HEAT INDEX OVER THE CITY OF BACOR, CAVITE REACH DANGEROUS LEVELS.**

**WHEREAS**, the Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) reported that the temperature over the City of Bacoor, Cavite on 3 March 2025 and 4 March 2025 shall exceed 34 degrees Celsius.

**WHEREAS**, the Department of Health (DOH) advised the general public to avoid exposing themselves in unshaded areas whenever the heat index exceeds 33 to 41 degrees Celsius as doing so may potentially cause heat strokes, heat cramps and other health problems that can become fatal.

**WHEREAS**, Department of Education (DepEd) Order No. 022, Series of 2024 serves as primary guide for suspensions of classes and work in schools during natural disasters and calamities. This gives school heads the authority and discretion to suspend in-person classes and shift to alternative modes in cases of extreme heat.

**WHEREAS**, Section 16 of Republic Act No. 7160 provides that local governments have the power to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

**WHEREAS**, the City Government needs to adopt policies that are flexible and that can be implemented right away whenever the threat of extreme weather conditions are affecting or are poised to affect the City of Bacoor in order to promote the general welfare.

**NOW THEREFORE**, upon motion of Hon. Reynaldo D. Palabrica and Hon. Rogelio M. Nolasco, unanimously seconded by the rest of the members of the City Council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5<sup>th</sup> Sangguniang Panlungsod in regular session duly assembled to respectfully request and authorize the City Mayor, Hon. Strike B. Revilla, to suspend classes in all levels whenever the heat index over the City of Bacoor, Cavite exceed 40 degrees Celsius.

**RESOLVED FURTHER**, that classes in colleges and universities operating within the City of Bacoor shall be suspended upon the advise of the administrators of the said educational institutions.

**RESOLVED LASTLY**, to furnish the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), all education institutions in the City of Bacoor, and other government agencies concerned with copies hereof in accordance with law.
