**A RESOLUTION DIRECTING THE PUNONG BARANGAY AND OTHER OFFICIALS OF BARANGAY TALABA II, CITY OF BACOR, CAVITE TO PAY THE SALARIES AND HONORARIA OF FORMER PUNONG BARANGAY ABITO E. MAHILAC, FORMER BARANGAY TREASURER AUGUSTO V. CABAHUG, AND FORMER BARANGAY EMPLOYEE JUAN M. PANTE FOR PUBLIC SERVICES RENDERED BY THEM ON NOVEMBER 2023.**

**WHEREAS**, on 18 December 2024, Mr. Abito E. Mahilac (Mahilac), Mr. Augusto V. Cabahug (Cabahug), and Mr. Juan M. Pante (Pante) filed a complaint against Punong Barangay Rodolfo Bañas Jr. (respondent Bañas) and Barangay Treasurer Janette G. Leonor (respondent Leonor) — both of whom are incumbent officials of Barangay Talaba II — for their alleged unjustified refusal to pay the salaries and honoraria of the complainants for November 2023.

**WHEREAS**, Mahilac was the former Punong Barangay of Talaba II before respondent Bañas was elected to the same position. Cabahug, on the other hand, was the Barangay Treasurer of Talaba II while Pante was an employee of the same barangay when Mahilac was still its Punong Barangay.

**WHEREAS**, the said complaint was referred to the Committee on Ethics, Good Government, and Government Reorganization which conducted a number of hearings on the said complaint attended by the opposing parties.

**WHEREAS**, during the course of the said hearings, the parties amicably settled their differences on the condition that respondent Bañas and Leonor shall pay the salaries and
