CITY RESOLUTION NO. 2025-689 SERIES OF 2025

A RESOLUTION ADOPTING DILG MEMORANDUM CIRCULAR NO. 2019-100 ENTITLED: "DESIGNATION OF LOCAL POPULATION OFFICERS AND MOBILIZATION OF COMMUNITY OFFICIALS, VOLUNTEERS, AND WORKERS TO INTENSIFY THE IMPLEMENTATION OF THE NATIONAL PROGRAM ON POPULATION AND FAMILY PLANNING (NPPFP) AND RECOMMENDING THAT THE BARANGAYS IN THE CITY OF BACOR, CAVITE ADOPT AND IMPLEMENT THE SAME".

WHEREAS, Republic Act No. 10354 (the "Responsible Parenthood and Reproductive Health Act of 2012" or "RPRH Law") recognizes the right of Filipinos to decide freely and responsibly on their desired number and spacing of children, within the context of responsible parenthood and informed choice, and to access needed reproductive health care information and services.

WHEREAS, the administration of former President Rodrigo Duterte set a 10-point socio-economic agenda which includes, among others, the strengthening of the RPRH Law implementation to enable poor couples to make informed choices on financial and family planning.

WHEREAS, one of the 17 Sustainable Development Goals to end poverty and fight inequality and injustice in the 2030 Agenda for Sustainable Development is the goal of ensuring universal access to sexual and reproductive health care services and rights, which the Philippines committed to achieve by 2030.

WHEREAS, the findings of the 2013 Philippine National Demographic and Health Survey (NDHS) carried out by the Philippine Statistics Authority (PSA) show that at least six million women, of which two million are poor, have unmet need for any modern method of contraception, and remain unable to fully exercise their reproductive rights.

WHEREAS, DILG Memorandum Circular No. 2019-100 was issued to provide guidelines in the implementation of key strategies at the local level towards the intensified implementation of the National

Program on Population and Family Planning (NPPFP) through the designation of Local Population Officers or Coordinators.

WHEREAS, Section 5.3 of DILG Memorandum Circular No. 2019-100 enjoined all barangays in the country to tap and capacitate barangay officials and their community volunteers and workers such as the Barangay Service Point Officers, Barangay Population Volunteers, Barangay Health Workers, Barangay Nutrition Scholar, parent leaders, and other community-based workers.

WHEREAS, there is a need for the City of Bacoor to adopt DILG Memorandum Circular No. 2019-100 as it will promote the advocacy of the national program on population and family planning particularly at the community level in the delivery of the full range of family planning information and services especially among the marginalized and underserved population.

NOW THEREFORE, upon the motion of Hon. Reynaldo D. Palabrica, unanimously seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session assembled to support the intention of the local government to pass a resolution adopting DILG Memorandum Circular No. 2019-100 designating local population officers and mobilization of community officials, volunteers, and workers to intensify the implementation of the national program on population and family planning" (NPPFP), and recommending that the barangays in the City of Bacoor, Cavite to adopt and implement the same.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the Liga ng mga Barangay, the Office of the Population Development, the Office of the City Health Services (OCHS), and other government agencies concerned with copies of this resolution.
