WHEREAS, the City Government of Bacoor is mandated by law to protect the general public from infectious diseases and other health concerns.

WHEREAS, Republic Act No. 11332, also known as the "Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act", was signed into law on August 22, 2018, and mandates the establishment of a system for the mandatory reporting of notifiable diseases and health events of public health concern, including the imposition of penalties for non-compliance.

WHEREAS, the Sangguniang Panlungsod deliberated on the said matter and recommended the adoption of the said Republic Act.

NOW THEREFORE, upon the motion of Hon. Reynaldo D. Palabrica, unanimously seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session assembled to pass a resolution adopting Republic Act no. 11332 or "Mandatory Reporting of Notifiable Diseases and Health Events of Public Health Concern Act".
