A RESOLUTION ADOPTING THE NATIONAL NUTRITION COUNCIL (NNC) GOVERNING BOARD RESOLUTION NO. 1, SERIES OF 2022 ENTITLED: "ADOPTING THE NATIONAL POLICY ON NUTRITION IN EMERGENCIES, TASKING NNC GOVERNING BOARD MEMBER AGENCIES TO ENSURE THE EFFICIENT AND EFFECTIVE IMPLEMENTATION OF THE POLICY, AND TASKING THE NUTRITION CLUSTER TO FORMULATE THE APPROPRIATE ADVISORIES, GUIDELINES AND OTHER MATERIALS TO DISSEMINATE AND IMPLEMENT THE POLICY".
