WHEREAS, promoting and protecting the physical, moral, spiritual, intellectual, and social well-being of Bacooreños is among the top priorities of the City Government of Bacoor as evidenced by its consistent implementation of various programs that will ensure that all nutritionally compromised people residing within the City of Bacoor receive the proper nourishment, vitamins, and medical treatment as may be needed.

Palabrica, unanimously seconded by the rest of the council in regular session assembled, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the 5th Sangguniang Panlungsod of the City of Bacoor to adopt Republic Act No. 8172 or " An Act Promoting Salt Iodization Nationwide" and for related purposes.
