A RESOLUTION INTERPOSING NO OBJECTION TO THE INTENT OF VERTEX ENTERTAINMENT AND RESORTS CORPORATION TO DEVELOP AND OPERATE A CASINO UNDER THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) CASINO FILIPINO OPERATION AT THE BRITTANY HOTEL VILLAR CITY, DAANG HARI ROAD CORNER VILLAR AVENUE, BARANGAY MOLINO 4, CITY OF BACOOR, CAVITE.

WHEREAS, Section 447, (3) of Republic Act. No. 7160 (otherwise known as the "Local Government Code of 1991") grants the Sangguniang Panlungsod the power, among others, to grant franchises, enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality and to regulate any business, occupation, or practice of profession or calling which does not require government examination within the municipality and the conditions under which the license for said business or practice of profession may be issued or revoked.

WHEREAS, Vertex Entertainment and Resorts Corporation is a domestic corporation duly organized and existing under and by virtue of Philippine laws.

WHEREAS, Vertex Entertainment and Resorts Corporation intends to operate a world-class casino and other gaming activities approved by the Philippine Amusement Gaming Corporation (PAGCOR) situated at the Brittany Hotel Villar City, Daang Hari Road corner Villar Avenue, Barangay Molino 4, City of Bacoor, Cavite.

WHEREAS, after a thorough deliberation on the said matter, majority of the members of the 5th Sangguniang Panlungsod of Bacoor City, Cavite decided not to pose any objection to the granting of a business permit by the City Mayor to Vertex Entertainment and Resorts Corporation to allow the latter to operate a casino, and other gaming activities, approved by the PAGCOR within the City of Bacoor, Cavite subject, however, to the strict

compliance of the said Corporation to certain conditions hereinafter set forth.

NOW, THEREFORE, upon motion of Councilor Michael E. Solis unanimously seconded by all the councilors present in regular session assembled, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod not to pose any objection to the granting of a business permit by the City Mayor to the Vertex Entertainment and Resorts Corporation for the latter's operation of a casino and other gaming activities approved by the PAGCOR at the site mentioned above within the City of Bacoor, Cavite provided that the said Corporation will strictly comply with the following conditions, to wit:

> The said business permit shall be effective for only one (1) year, which period shall be reckoned from the date of issuance of such business permit and shall only be issued upon payment by Vertex Entertainment and Resorts Corporation of the appropriate business permit fees.

- Vertex Entertainment and Resorts Corporation shall not allow any minor, or any student in uniform irrespective of age, from entering, loitering, or playing any game of chance within the premises of the casino that it intends to operate within the City of Bacoor, Cavite
- The said business permit shall be limited to the casino gaming premises within Brittany Hotel Villar City, Daang Hari Road corner Villar Avenue, Barangay Molino 4, City of Bacoor, Cavite.
- Vertex Entertainment and Resorts Corporation must first obtain a Fire Inspection Safety Clearance from the Office of the Fire Marshall of Bacoor, Cavite before the said business permit can be issued.
 - Vertex Entertainment and Resorts Corporation must submit its Certificate of Incorporation, Articles of Incorporation and By-laws as duly issued and/or approved by the securities and Exchange Commission (SEC) with the Business Permit and Licensing Department (BPLD) of the city government before a business permit can be issued to the Corporation.
 - Vertex Entertainment and Resorts Corporation must submit to the BPLD and to the Office of the Secretary of the Sangguniang Panlungsod a certified true copy of its PAGCOR franchise.
 - Vertex Entertainment and Resorts Corporation must pay any and all pending liabilities and taxes, which may include

RESOLVED LASTLY, to furnish the Office of the City Mayor, the Vertex Entertainment and Resorts Corporation, the BPLD, and other government agencies concerned with copies of this Resolution.


