A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE SUPPLEMENTAL AGREEMENT (AMENDING MEMORANDUM OF AGREEMENT DATED 19 AUGUST 2024) ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE 14TH CYCLE OF THE SUPPLEMENTARY FEEDING PROGRAM.

WHEREAS, on 10 April 2025, the Office of the City Mayor formally requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Supplemental Agreement between the City Government of Bacoor and the Department of Social Welfare and Development (DSWD) – Field Office IV-A CALABARZON for the 14th Cycle of the Supplementary Feeding Program for the 120 feeding days provision for identified beneficiaries.

WHEREAS, on 19 August 2024, the City Government of Bacoor and the DSWD signed and entered into a Memorandum of Agreement (MOA) for the implementation of the feeding program.

WHEREAS, the said MOA may be amended under Article III (Amendments) upon mutual consent of city government and DSWD provided that amendments shall be covered by a Supplemental Agreement signed by the aforementioned parties.

WHEREAS, the Office of the City Mayor submitted a draft Supplemental Agreement to the Sangguniang Panlungsod for its review and consideration. The proposed

SUPPLEMENTAL AGREEMENT (Amending Memorandum of Agreement Dated 19 August 2024)

KNOW ALL PERSONS BY THESE PRESENTS:

An amendment to the Memorandum of Agreement dated 19 August 2024 is made and entered into this ___ day of _____ 2025 at _____, by and between:

The DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE IV-A (CALABARZON) government agency created pursuant to Republic Act No. 5416, through its FIELD OFFICE IV-A, with the office address at Alabang Zapote Rd. Alabang, Muntinlupa City, Philippines, 1770 and represented by its REGIONAL DIRECTOR, BARRY R. CHUA, M.D., herein referred to as "DSWD";

-and-

The CITY GOVERNMENT OF BACOR, a local government unit created and existing under the laws of the Republic of the Philippines, with principal office address at Bacor Government Center, Bacor Boulevard, Barangay Bayanan, Bacor City, Province of Cavite, represented herein by its City Mayor, Hon. STRIKE B. REVILLA, pursuant to his authority conferred and embodied in Sangguniang Panlungsod Resolution No. _____, Series of 2025, hereinafter referred to as the "LGU BACOR".

"PARTY" shall mean either DSWD or LGU BACOR, as applicable, and "PARTIES" shall mean DSWD and LGU BACOR collectively.

WITNESSETH:

WHEREAS, the PARTIES entered into an Agreement for the Implementation of the supplementary feeding program with the following particular details:

WHEREAS, under Article III (Amendments) thereof, "The MOA may be amended or revoked only upon mutual agreement of both Parties, provided that all amendments shall be covered by a Supplemental Agreement signed by both Parties, which shall be deemed incorporated as integral parts of this MOA;

NOW, THEREFORE, the **PARTIES**, after mutual consultation agree to amend the above-cited Memorandum of Agreement in the following manner:

1. The provision in Article IV, Effectivity¹, shall be amended as follows:

Article IV. Effectivity - This MOA shall take effect upon the signing of the parties and shall remain valid and existing from CY2024 to 2026, providing it shall not exceed the Extended Payment Period, as stated further under the applicable GAA General Provisions unless otherwise revoked or terminated by either one of the parties.

2. All other terms and conditions of the original Memorandum of Agreement shall remain in full force and effect unless incompatible with the present amendments in which case, it shall be interpreted or modified accordingly in order to attain the purpose for which these amendments are established.
3. **AUTHORITY TO SIGN** — The signatories to this Amended Memorandum of Agreement affirm that they are authorized to represent their respective agencies/institutes/corporations to enter into, execute, and sign this Agreement.
4. **EFFECTIVITY** - This Supplemental Agreement to the Memorandum of Agreement shall take effect upon the signing of the **PARTIES** and shall remain valid and existing until the completion of the 120 feeding days for the 14th to 16th cycle implementation or within the applicable calendar year, whichever comes first unless otherwise revoked or terminated by either one of the parties.
