CITY RESOLUTION NO. 2025-703 Series of 2025

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN BARANGAY SAN NICOLAS 3, CITY OF BACOOR, CAVITE AND AUTHORIZING THE RELEASE OF TWO MILLION PESOS (PHP 2,000,000.00) FROM THE CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND TO BE USED FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, a fire broke out in a residential unit in Golden Site Street, Sitio Latero in Barangay San Nicolas 3 in the early morning of 24 April 2025 that rapidly spread to adjacent residential units which were mostly made from light materials thereby affecting around 83 families whose houses were destroyed.

WHEREAS, the Bacoor City Disaster Risk Reduction and Management Council (CBDRRMC) passed Resolution No. 03, Series of 2025 dated April 24, 2025, requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Sitio Latero, Barangay San Nicolas 3 and authorizing the release of Two Million Pesos (Php 2,000,000.00) from the City Disaster Risk Reduction and Management Fund to be used for financial assistance, relief goods, and other incidental expenses related to relief and rehabilitation operations.


