A RESOLUTION EXPRESSING THE PROFOUND APPRECIATION OF THE CITY GOVERNMENT FOR THE EXEMPLARY PUBLIC SERVICE RENDERED BY THE LATE MR. LORETO LIBID AS MUNICIPAL SECRETARY OF THE DEFUNCT SANGGUNIANG BAYAN OF BACOR, CAVITE.

WHEREAS, Section 2 of City Ordinance No. 91-2023 (the "Bacoor Bereavement Protocol Ordinance") provides that all former and incumbent elected officials of the City of Bacoor and all appointed heads of the departments and units under the Office of the City Mayor including the Secretary of the Sangguniang Panlungsod shall, upon their demise, be honored by the City Government and shall be subject to funeral and burial rites to be conducted pursuant to the provisions of the said legislation.

WHEREAS, the City Mayor received information that Mr. Loreto Libid, the former Municipal Secretary of the defunct Sangguniang Bayan of Bacoor, Cavite during the term of office of Mayor Buencamino M. Cruz (1988-1990), passed away on 15 May 2025.

WHEREAS, the City Mayor requested the Sangguniang Panlungsod to issue a resolution recognizing the invaluable contributions of Mr. Libid in the development of the City of Bacoor.

WHEREAS, Mr. Libid's LinkedIn page described him as a "professional man who can translate complex concepts into accessible form" and a "civic minded man who thinks and writes with clarity" who gained the said attributes after working for 30 years with the Gotianum Group of Companies and as a consultant of the Philippine Enterprise Development Foundation for another eight years.
